

ORDINANCE O-4486

AN ORDINANCE OF THE CITY OF KIRKLAND AMENDING CERTAIN CHAPTERS IN TITLE 21 OF THE KIRKLAND MUNICIPAL CODE RELATING TO ELECTRICAL PERMITS.

1 WHEREAS, Title 21 of the Kirkland Municipal Code ("KMC")
2 provides regulations governing building and construction in Kirkland,
3 including but not limited to electrical and administrative regulations; and
4

5 WHEREAS, RCW 19.28 requires cities that enforce an electrical
6 code to adopt a code that is equal to, higher or better than the state
7 electrical code; and
8

9 WHEREAS, Kirkland's electrical code contained in Chapter 21.70,
10 and adopted in 2009, is based on the 2008 National Electrical Code
11 (NEC) while the state has adopted and amended the 2014 NEC, which
12 means Kirkland's electrical code may no longer be equal to, higher or
13 better than the state's code; and
14

15 WHEREAS, the MyBuildingPermit.com organization and the
16 Electrical Committee of the Washington Association of Building Officials
17 have updated their Washington Cities Electrical Code which is also based
18 on the 2014 NEC but amends it in a manner that better addresses the
19 concerns of cities while still remaining equal to, better or higher than
20 the state's code and should therefore be adopted as Kirkland's electrical
21 code; and
22

23 WHEREAS, the Washington Cities Electrical Code has clarified
24 further when a plan review is required for an electrical permit and this
25 clarification should be added to the KMC; and
26

27 WHEREAS, the electrical permit fees in Chapter 21.74 of the
28 Kirkland Municipal Code do not specifically address roof mounted
29 photovoltaic panels and a new flat fee for these installations would be
30 less than our current fee schedule and more reflective of the City's costs.

32 NOW, THEREFORE, the City Council of the City of Kirkland do
33 ordain as follows:
34

35 Section 1. Section 21.70.010 of the KMC is hereby amended to
36 read as follows:

37 **21.70.010 Washington Cities Electrical Code Adopted**

38 The ~~June 22, 2009~~ January 22, 2014 edition of the Washington Cities
39 Electrical Code, Parts one and three, as published by the Washington
40 Association of Building Officials is adopted and shall be known as the
41 Kirkland Electrical Code.

42 Section 2. Table 7 of Chapter 21.74 of the KMC is amended as
 43 follows:

44 Section 3. Subsection 21.06.275(2)(F) of the KMC is amended
 45 to read as follows:
 46

47 (F) Plan Review Required. Electrical plan review is required for all
 48 new or altered electrical projects in the following occupancies and/or
 49 installations:
 50

51 Exception: Subject to the approval of the Building Official, electrical
 52 plan review is not required for the occupancies and/or installations listed
 53 below when the scope of work is for conduit(s) only and electrical plans
 54 for the project have been submitted for review.
 55

56 (i) Educational, institutional, or health care facilities/buildings as
 57 follows:
 58

- 59 a. Hospital;
- 60
- 61 b. Nursing home unit or long-term care unit;

- 62 c. Boarding home;
- 63
- 64 d. Assisted living facility;
- 65
- 66 e. Private alcoholism hospital;
- 67
- 68 f. Alcoholism treatment facility;
- 69
- 70 g. Private psychiatric hospital;
- 71
- 72 h. Maternity home;
- 73
- 74 i. Ambulatory surgery facility;
- 75
- 76 j. Renal hemodialysis clinic;
- 77
- 78 k. Residential treatment facility for psychiatrically impaired children
- 79 and youth;
- 80
- 81 l. Adult residential rehabilitation center;

- 83 m. Educational facilities;

- 87 Exception: Electrical plan review is not required for the above
- 88 educational, institutional, or health care facilities/buildings where:

- 95 c. Modification to existing electrical installations where all of the

- 102 equipment per NEC 700.12(F);

- 105 electrical system as defined in NEC 517.2; and

- 107 4. Service and feeder load calculations are increased by five percent
- 108 or less;

- 110 d. Stand-alone utility fed services that do not exceed two hundred
- 111 fifty volts and less than one hundred amperes where the project's
- 112 distribution system does not include:

- 114 1. Emergency systems other than listed unit equipment per NEC
- 115 700.12(F);

2. Critical branch circuits or feeders as defined in NEC 517.2; or

3. A required fire pump system.

~~(ii) Alterations in nonresidential occupancies two thousand five hundred square feet and greater.~~

(iii) Installations in occupancies, except one- and two-family dwellings, where a service or feeder rated one hundred amperes or greater is installed or altered or if more than one hundred amperes are added to the service or feeder.

~~(iviii)~~ All work on electrical systems operating at/over six hundred volts.

(iv) All commercial generator installations or alterations.

(vi) All work in areas determined to be hazardous (classified) locations by the NEC.

(vii) If sixty percent or more of luminaires change, and there is an increase in the lighting load.

(viii) Installations of switches or circuit breakers rated four hundred amperes or over except for one- and two-family dwellings.

~~(ixviii)~~ Wind-driven generators.

(ix) Solar photovoltaic systems.

(xi) Any proposed installation which cannot be adequately described in the application form.


(xii) Temporary electrical services exceeding four hundred amps.

Section 4. If any provision of this ordinance or its application to any person or circumstance is held invalid, the remainder of the ordinance, or the application of the provision to other persons or circumstances is not affected.

Section 5. This ordinance shall be in force and effect five days from and after its passage by the Kirkland City Council and publication pursuant to Section 1.08.017, Kirkland Municipal Code in the summary form attached to the original of this ordinance and by this reference approved by the City Council.



PUBLICATION SUMMARY
OF ORDINANCE O-4486

AN ORDINANCE OF THE CITY OF KIRKLAND AMENDING CERTAIN CHAPTERS IN TITLE 21 OF THE KIRKLAND MUNICIPAL CODE RELATING TO ELECTRICAL PERMITS.

SECTION 1. Updates Section 21.70.010 of the Kirkland Municipal Code (KMC) to the January 22, 2014, edition of the Washington Cities Electrical Code.

SECTION 2. Amends Table 7 of Chapter 21.74 of the KMC related to the miscellaneous electrical inspection fee.

SECTION 3. Amends Subsection 21.06.275(2)(F) of the KMC relating to required plan review.

SECTION 4. Provides a severability clause for the ordinance.

SECTION 5. Authorizes publication of the ordinance by summary, which summary is approved by the City Council pursuant to Section 1.08.017 Kirkland Municipal Code and establishes the effective date as five days after publication of summary.

The full text of this Ordinance will be mailed without charge to any person upon request made to the City Clerk for the City of Kirkland. The Ordinance was passed by the Kirkland City Council at its meeting on the 7th day of July, 2015.
