ORDINANCE NO. 9.

AN ORDINANCE PROVIDING FOR THE APPOINTMENT

OF AN ACTING TOWN ATTORNEY,

BE IT OR MAINED BY THE COUNCIL OF THE TOWN OF KIRKLAND: -

SECTION I.
