ORDINANCE NO. 27.

AN ORDINANCE AUTHORIZING THE APPOINTMENT OF A CITY ATTORNEY AND FIXING THE COMPENSATION OF SAID ATTORNEY.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF KIRKLAND:

SEC. 1. The Mayor is hereby authorized and directed to appoint a City Attorney.

SEC. 2. The compensation of said attorney for the year ending January 8th, 1908, is hereby fixed in the sum of One hundred Fifty Dollars (\$150.00) payable on the first days of April, July, October and January. For litigation before the Police Court, said attorney shall receive, in case the controversy shall terminate in favor of the city, Ten Dollars (\$10.00) additional compensation for each case. When litigation is before the Superior or Supreme Courts of the State, upon appeal or otherwise, the matter of compensation therefor shall be a subject for separate arrangement by the council and said attorney.

ORDINANCE NO. 27.

AN ORDINANCE AUTHORIZING THE APPOINTMENT OF A CITY ATTORNEY
AND FIXING THE COMPENSATION OF SAID ATTORNEY.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF KIRKLAND:

SECTION I.

The Mayor is hereby authorized and directed to appoint
a City Attorney.

SECTION II.

The compensation of said attorney for the year ending
January 8th, 1908, is hereby fixed in the sum of One Hundred Fifty
Dollars (\$150.00) payable on the first days of April, July, October
and January. For litigation before the Police Court, said attorney
shall receive, in case the controversy shall terminate in favor of
the city, Ten Dollars (\$10.00) additional compensation for each case.
When litigation is before the Superior or Supreme Courts of the State,
upon appeal or otherwise, the matter of compensation therefor shall
be a subject for separate arrangement by the council and said attor-
ney.
