

ORDINANCE NUMBER 59.

An Ordinance vacating all of Pike Street as the same appears in the Plat of HARRY WHITE and COMPANY'S Commercial Addition to the town of Kirkland.

Be it Ordained by the Council of the Town of Kirkland.

SECTION (1). In pursuance of the petition of Annie M. Hodson and Sarah M. Rodman for the vacation of all of Pike Street as the same appears in the plat of Harry White and Company's Commercial Addition to the Town of Kirkland, it appearing to the council that more than twenty days notice of the hearing of said petition has been given as required by law, that the owners of all property abutting on said Pike Street have all consented in writing to said vacation, said written consents having been filed with this council, and it further appearing to the council that the vacation of said street will be in furtherance of the public welfare, it is hereby ordered and ordained that all of Pike Street as the same appears in the Plat of Harry White and Company's Commercial Addition to the Town of Kirkland be and the same is hereby vacated.

AN ORDINANCE VACATING ALL OF PIKE STREET AS THE SAME APPEARS IN THE PLAT OF HARRY WHITE AND COMPANY'S COMMERCIAL ADDITION TO THE TOWN OF KIRKLAND.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF KIRKLAND:

SECTION I.
