ORDINANCE NG. 60

AN GRDINANCE approving the assessment roll of Local Improvement District No. 14 of the Town of Kirkland for the improvement of Lake Avenue from Market Street to County Road No. 454, and of said County Road No. 454 from Lake Avenue to the County Road at the shore end of the King County Ferry Landing by grading the same, repairing bulkheads and constructing wooden sidewalks therein, as provided by Ordinance No. 50 of said Town of Kirkland, and providing for the collection thereof.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF KIRKLAND: SECTION I.

That the assessment roll for the levying of special assessments to defray the cost of improving Lake Avenue in the Plat of the Town of Kirkland from Market Street eastward to its intersection with the east margin of the unnamed street known as County Road No. 454, and on said unnamed street known as county Road No. 454 from its intersection with Lake Avenue southeasterly to the county Road (or Kirkland Avenue) at the shore end of the King County Ferry Landing, in the Town of Kirkland, King County, Washington, by filling in and grading the same and repairing portions of the existing bulkheads and constructing such new bulkheads as may be necessary to sustain the roadway within said street, and by constructing upon said bulkheads along the southerly and westerly sides of said roadway a wooden sidewalk six feet in width and by constructing upon laying the necessary constructing and laying the necessary construction. width, and by constructing and laying the necessary crossings, culverts, gutters and drains, all in accordance with the plans and specifications prepared by the acting Town Ingineer, as provided by Ordinance No. 50, of said Town of Kirkland, be and the same is hereby approved and confirmed, and the property therein listed and assessed is benefit dealered to approve the same and assessed in benefit dealered to approve the same and assessed in benefit dealered to approve the same and assessed in benefit dealered to approve the same and assessed in benefit dealered to approve the same and assessed in benefit dealered to approve the same and assessed in benefit dealered to approve the same and assessed in benefit dealered to approve the same and assessed in the same and the same an listed and assessed is hereby declared to constitute Local Improvement District No. 14, of said Town of Kirkland.

That the amount set opposite each lot or portion of a lot in said roll is hereby levied and assessed against said lot or portion of a lot and declared a lien thereon, and the amount appearing in said roll as the amount required by law to be paid by the Town, is hereby declared a just charge against said Town of Kirkland.

SECTION III.

That said roll be delivered to the Town Treasurer and that he proceed to collect the same in the manner provided by law.
