ORDINANCE NO. 82

An ordinance providing for the appointment by the mayor of a marshal for the town of Kirkland, defining the duties of the said Marshal, fixing the compensation, repealing ordinance No. 70, entitled "An Ordinance creating new duties for the town marshal, and amending existing ordinances so far as they shall relate to his compensation or are inconsistent herewith", and repealing ordinance No. 16, entitled "An Ordinance providing for the appointment, and fixing the duties, term and compensation of the superintendent of Streets", and repealing Ordinance No. 15 entitled, "An Ordinance fixing the duties, term, and compensation of the Town Marshal."

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KIRKLAND:

SECTION I.

That the Mayor of the Town of Kirkland be, and he hereby is, empowered to appoint a Marshal for the Town of Kirkland who shall hold office during the pleasure of the said Mayor, or until such time as this ordinance may be repealed by the town council of the town of Kirkland.

SECTION II.

That the said Marshal so appointed shall receive for his services the sum of seventy-five dollars per month payable monthly from and after the date of his appointment.

SECTION III.

That the duties of the Marshal of the town of Kirkland shall be such as are provided by the laws of the State of Washington for towns of the fourth class. It shall also be the duty of the said town marshal to preserve peace and order in the town, obey and carry out all orders of the Mayor and Council, and see that the ordinances of the town are strictly enforced.

SECTION IV.

That it shall be the furtherduty of the said marshal to have supervision over all streets, alleys, sidewalks and high-ways within the limits of the town, and their repair, construction and maintenance, subject to the direction of the Mayor and Council.

SECTION V.

That the duties of said marshal in looking after the highways shall include not less than eight hours work each and every working day on the streets, alleys, and sidewalks of said town of Kirkland.

SECTION VI.

That an Ordinance No. 70, and entitled, "An ordinance creating new duties for the town marshal, and amending existing ordinances so far as they shall relate to his compensation or are inconsistent herewith", be and the same is hereby repealed.

SECTION VII.

That Ordinance No. 16, entitled "An ordinance providing for the appointment, and fixing the duties, term and compensation of the Superintendent of Streets," be and the same is hereby repealed.

SECTION VIII.

That ordinance No. 15, entitled, "An ordinance fixing the duties, term and compensation of the town marshal," be and the same is hereby repealed.

Ordinance No. 82

An Ordinance Providing for the Appointment by the Mayor of a Marshal for the Town of Kirkland, Defining the Duties of the said Mar-shal, fixing the Compensation. Repealing Ordinance No. 70, Entitled, "An Ordinance Creating New Duties

for the Town Marshal, and Amend-ing Existing Ordinances so far as they shall relate to his compensation, or one inconsistent herewith," and repealing Creamance No. 16. Emitted "An Ordinance providing for the appointment, and fixing the duties, term and compensation of the superintendent of Streets," and repealing Ordinance No. 15 Emitted, An Ordincanance No. 15 'Emitted, An Ottom-ance fixing the duffer, term and com-pensation of the Town Marshal."

Be it ordained by the town coun-cil of the Town of Kirkland:

Section I.
That the Mayor of the town of Kirkland be, and he hereby is, em-powered to appoint a Marshal for the Town of Kirkland who shall hold office during the pleasure of the said Mayor, or until such time as this ordinance may be repealed by the town council of the town of Kirkland.

Section II. That the said Marshal so appointed shall receive for his services the: sum of seventy-five dollars per month payable monthly from and after the date of his appointment.

Section III. That the duties of the Marshal c' are provvided by the laws of State of Washington for towns of the fourth class. It shall also be the duty of the said town marshal to preserve peace and order in the town, obey and carry out all orders of the Mayor and Council, and see that the ordinances of the town are strictly enforced. Section IV.

That it shall be the further duty of the said marshal to have supervision over all streets, alleys sidewalks and high-ways within the limits of the town, and their repair, con-struction and maintenance, subject to the direction of the Mayor and Council.

Section V. That the duties of said marshall in looking after the highways shall include not less than eight hours shall work each and every working day on the streets, alleys and sidewalks of said town of Kirkland.

Section VI. That an Ordinance No. 70, and entitled,"An ordinance creating new duties for the town marshal, and amending existing ordinances so far as they shall relate to his compensation or are inconsistent herewith," be and the same is hereby repealed.

Section VII.
That Ordinance No .16, entitled, "An ordinance providing for the ap-apointment, and fixing the duties, term and compensation of the Super-intendent of Streets," be and the same is hereby repealed.

Section VIII. That ordinance No. 15, Entitled, "An Ordinance fixing the duties, tert and compensation of the town marshal," be and the same is hereby repealed.
