ORDINANCE N O. 90

An ordinance amending section II. of Ordinance No. <sup>82</sup>~~62~~ of the town of Kirkland.

BE IT ORDAINED BY THE MAYOR AND TOWN COUNCIL OF THE TOWN OF KIRKLAND:

SECTION I.

That said Section two of said ordinance numbered <sup>82</sup>~~62~~ of the town of Kirkland be and the same is hereby amended to read as follows:

That the said marshal shall receive for his services the sum of ten dollars per month while acting in the capacity of town Marshall under the direction of the Mayor and shall receive the further sum of sixty-five dollars per month when acting in the capacity of Supervisor of Streets under and by the order of the Mayor.

**ORDINANCE NO. 93.**  
 AN ORDINANCE prohibiting the running at large within the corporate limits of the Town of Kirkland of any horse, mule, cow or other animal from the hour of seven o'clock P. M. until the hour of six o'clock A. M. with a bell or any other noise-making device fastened to the neck or any other part of said animal, and providing a penalty for the violation of this Ordinance.

Be it Ordained by the Council of the Town of Kirkland:

Section 1. It shall be unlawful for any person or persons owning, having in charge or under control any horse, mule, cow, or other animal, to permit, suffer or allow said animal to run at large within the corporate limits of the town of Kirkland from the hour of seven o'clock P. M. until the hour of six o'clock A. M. with a bell or any other noise-making device fastened to the neck or any other part of said animal.

Sec. 2. Any person violating any of the provisions of this ordinance shall be subject to a fine in any sum of not less than one dollar nor more than twenty-five dollars.

**ORDINANCE NO. 94.**  
 AN ORDINANCE establishing and creating within the corporate limits of the Town of Kirkland a street and highway sixty feet in width running in a Northwesterly direction along the lake front and intersecting with Lake Avenue according to and in conformity with one certain tracing filed with the town clerk of the Town of Kirkland on the 20th day of May, A. D. 1912, and marked "A Part of Ordinance No. 94," said street and highway to be hereafter known as Lake Avenue South; also changing the boundary line of Lake Avenue so as to make the same conform to the said tracing hereinbefore mentioned and vacating so much of the said Lake Avenue and the said Lake Avenue South as is not embraced within the boundary lines of the said Lake Avenue and Lake Avenue South as created and established by this Ordinance.

Be it Ordained by the Council of the Town of Kirkland:

Section 1. That there be and there is hereby established and created within the Town of Kirkland a street and highway sixty feet in width running in a Northwesterly direction along the lake front of Lake Washington to intersect with Lake Avenue as shown by and according to and in conformity with the tracing filed with the town clerk of the Town of Kirkland on the 20th day of May, A. D. 1912, and marked "A Part of Ordinance No. 94," said street and highway to be hereafter known as Lake Avenue South.

Sec. 2. That the boundary lines of the said Lake Avenue within the Town of Kirkland be and the same are hereby changed, wherever a change is made necessary and shown to exist by the tracing heretofore mentioned and filed, so as to make the boundary lines of the said Lake Avenue conform to the boundary lines as shown by the tracing filed with the town clerk of the Town of Kirkland on the 20th day of May, A. D. 1912, and marked "A Part of Ordinance No. 94."

Sec. 3. That so much of the said Lake Avenue and the said Lake Avenue South as is not embraced within the boundary lines of the said Lake Avenue and Lake Avenue South as created and established by this ordinance be and the same is hereby vacated.

Sec. 4. That this Ordinance shall take effect and be in full force from and after its passage and approval and publication.

Sec. 2. That this Ordinance take effect and be in full force from and after its passage, approval and publication.

**ORDINANCE NO. 97.**  
 AN ORDINANCE providing for the clearing and grading of New Hampshire Avenue, said improvement to be the full length and width of the said New Hampshire Avenue and to include one drain box made of 2x12 lumber commencing at a point marking the beginning of the north boundary line nearest Lake Washington and running thence east a distance of 630 feet, also the establishing of one gutter 40 feet or thereabouts, culvert across said avenue; creating Local Improvement District No. 21 and defining the boundaries thereof and providing for the assessment thereof.

Be it Ordained by the Council of the Town of Kirkland:

Section 1. That the said New Hampshire Avenue in the Town of Kirkland shall be cleared and graded its full length and width in accordance with the grade established by ordinance No. 96 and shall have constructed thereon one drain box 12x20 on the inside made

of 2x12 lumber, said drain box to commence at a point marking the beginning of the north boundary line nearest Lake Washington and running thence due east 630 feet; also the establishment of one 40-foot culvert across said avenue.

Sec. 2. The property to be specially benefited and assessed for said improvements shall be all the property within 100 feet of the north boundary line of the said New Hampshire Avenue and on the north side thereof running the full length of said avenue and all the property within 150 feet of the south boundary line of said New Hampshire Avenue and running the full length thereof; that all the property hereby declared to be benefited and subject to special assessment for said improvements shall be known as and shall constitute Local Improvement District No. 21.

Sec. 3. That the assessment shall be made in the manner as provided in Section 13 of Chapter 98 of the 1911 Session Laws by the street committee and engineer of the Town of Kirkland and filed with the town clerk.

Sec. 4. That when the said assessment roll shall have been filed with the town clerk for said local improvements and the date fixed for the hearing thereof by the council, the clerk shall give notice of such hearing and the time and place thereof. Such notice shall specify such time and place of hearing on such roll, and shall notify all persons who may desire to object thereto to make such objections in writing and to file the same with the clerk, at or prior to the date fixed for such hearing; and that at the time and place fixed and at such other times as the hearing may be continued to, the council will sit as a board of equalization for the purposes of considering such roll, and at such hearing, or hearings, will consider such objections made thereto, or any part thereof, and will correct, revise, raise, lower, change or modify such roll, or any part thereof, or set aside such roll and order that such assessment be made de novo, as

to such body shall appear just and equitable, and then proceed to conform the same by ordinance; that such notice shall be published for two issues in the News, the official paper, and that at least fifteen days must elapse between the date of last publication and the date fixed for the hearing.

Sec. 5. That after said assessment roll or amended or revised roll shall have been affirmed and ratified by the town council the same shall be certified to the town treasurer who shall within five days after the receipt thereof publish a notice in one issue of the News, the official paper, stating that such assessment roll (describing the same by number), has been certified to him for collection, and that unless payment is made within thirty days from the date of such notice, such assessment shall become delinquent and shall bear interest at the rate of eight per cent per annum together with a penalty of five per cent and that the said special assessment shall become a lien upon the property so assessed together with the interest and penalty and will be certified to the county treasurer for collection as provided by law.

Sec. 6. That this ordinance shall take effect and be in full force from and after its passage, approval and publication.

**ORDINANCE No. 98.**  
 Ordinance authorizing, and empowering the town of the town of Kirkland to file to the county treasurer of the County of King all delinquent assessments now due? Owing and unpaid on account of special improvements made in the said town of land, which said assessments notified shall state the amount due unpaid together with the interest thereon to date and shall direct said treasurer of the said County King to collect the same in the manner as provided by law.
