

ORDINANCE NO. 117

1 AN ORDINANCE providing for and ordering a supplemental
2 assessment upon the property embraced in Local Improvement District
3 No. 21, directing the preparation of an assessment roll
4 therefor.

5 WHEREAS the Town Council of the Town of Kirkland has heretofore
6 ordered the improvement of New Hampshire Ave street in
7 said town under Ordinance No. 97 creating Local Improvement
8 District No. 21; and

9 WHEREAS said improvement has been completed and accepted by
10 said town; and

11 WHEREAS an assessment has heretofore been levied and confirmed
12 against the property in said District for the payment of the costs
13 of said improvement; and

14 WHEREAS on account of a mistake and inadvertance the amount so
15 assessed, being the sum of \$ 633⁶⁰ was not, and is not
16 sufficient to pay the total cost and expenses of the improvement so
17 made and enjoyed by the owners of property in said Local Improvement
18 District; and

19 WHEREAS the Town Council upon due investigation has determined
20 and does hereby find and determine that the total deficiency in
21 said assessment is the sum of \$ 232.71;

22 NOW THEREFORE, BE IT ORDAINED BY the Council of the Town of
23 Kirkland, as follows:

24 Section 1. That a supplemental assessment is hereby ordered
25 to be made against all of the property included in Local Improvement
26 District No. 21 in an amount sufficient to take care of the
27 deficiency in the original assessment against said district, said
28 assessment to be made in accordance with the provisions of the law
29 and the ordinances existing at the time of the levy of such supple-
30 mental assessment. Provided: that such assessment shall be for
31 an amount which, together with the original assessment, shall not

1 exceed the actual cost and expense of the said improvement, together
2 with the accrued interest thereon, it being the intent hereof to
3 make said cost and expense of said Local Improvement payable by
4 the property specially benefited thereby.

5 Section 2. That the Engineer for Town of Kirkland
6 be and they are hereby directed to prepare an assessment roll for
7 such supplemental assessment which said roll shall include all
8 property included in said Local Improvement District. Said assess-
9 ment shall be made in accordance with the law and ordinances of said
10 town and pursuant to the provisions hereof.

11 Section 3. When said assessment roll shall have been so pre-
12 pared as herein ordered, the same shall be referred to the Town
13 Council, whereupon the Town Council shall fix a time for hearing of
14 protests thereon, and the Town Clerk shall give due and regular
15 notice of said hearing in the manner provided by law for original
16 assessments.
