Section 3. That there is hereby established a Local Improvement District to be called "Local Improvement District No. \_\_\_", which said district is described as follows: All the property between the termini of said improvement, to-wit: Pring Street, from the West line of Market Street in a northwesterly direction to the Melson Tract; James Street, from the junction of James and Spring Streets Northeast to Columbia Street, Columbia Street from the intersection of James and Columbia Street Northwest to the Nelson Tract, abutting upon, adjacent, vicinal, or presimate to such portions of said streets and avenues to a distance back from the marginal lines thereof, as provided by law.

That the cost and expense of said improvement shall be defrayed by special assessments payable by the mode of "Immediate Payment", as defined by law, and the ordinances of the Town of Kirkland. Warrants bearing interest at the rate of 8 per cent per annum until paid, shall be issued to the contractor for the redemption of as many of the warrants issued on the Local Improvement District Fund on estimates of the Town Engineer, as may not be redemmed in cash.

Section 5. This ordinance shall take effect and be in force from and after its passage and approval by the Mayor; and its publication; otherwise it shall take effect at the time it shall become an ordinance under the law.
