

ORDINANCE NO. 125

1 AN ORDINANCE providing for the improvement and grading of Central
2 Avenue from its intersection with Lake Avenue, in a northeasterly
3 direction up Central Avenue to the center line of ^{Oxford} Jersey Street
4 with a twenty foot top and a slope of 1 to 1, ~~also with a four~~
5 ~~foot plank walk on the north side thereof~~, and doing such other
6 work as may be necessary in connection therewith, all in ac-
7 cordance with plans to be prepared by the Town Engineer, all
8 in accordance with Resolution No. 111 of the Town Council
9 of the TOWN OF KIRKLAND, and creating a Local Improvement
10 District for such improvement, and providing that payment for
11 said improvement be made by special assessments upon property
12 in said district, payable by the mode of "Immediate Payment".

8 BE IT ORDAINED BY THE TOWN OF KIRKLAND, as follows:

9 Section 1. That Central Avenue be improved from its intersec-
10 tion with Lake Avenue, in a northeasterly direction up Central Avenue
11 to the center line of ^{Oxford} Jersey Street, by grading, with a twenty (20)
12 foot top and a slope of 1 to 1, ~~also with a four-foot plank side~~
13 ~~walk on the north side thereof~~, and that such other work be done as
14 may be necessary in connection therewith, according to the plans and
15 specifications therefor prepared under the direction of and by the
16 Town Engineer, and on file in the office of the Secretary of the
17 Council of the Town of Kirkland.

18 Section 2. That the cost and expense of said improvement, in-
19 cluding all necessary and incidental expenses shall be borne by and
20 assessed against the property included in the assessment district
21 hereinafter created, in accordance with law. The Town of Kirkland
22 shall not be liable in any manner for any portion of the cost and
23 expense of said improvement, except as herein provided.

24 Section 3. That there is hereby established a Local Improvement
25 District to be called "Local Improvement District No. 25",
26 which said district is described as follows: All the property
27 between the termini of said improvement, to-wit: On Central Avenue
28 from its intersection with Lake Avenue, in a northeasterly direction
29 up Central Avenue to the center line of ^{Oxford} Jersey Street, abutting
30 upon, adjacent, vicinal, or proximate to such portions of said
31 streets and avenues to a distance back from the marginal lines

1 thereof, as provided by law.

2 Section 4. That the cost and expense of said improvement shall
3 be defrayed by special assessments payable by the mode of "Immediate
4 Payment", as defined by law, and the ordinances of the Town of
5 Kirkland. Warrants bearing interest at the rate of 8 per cent per
6 annum until paid, shall be issued to the contractor for the redemp-
7 tion of as many of the warrants issued on the Local Improvement
8 District Fund on estimates of the Town Engineer, as may not be
9 redeemed in cash.

10 Section 5. This ordinance shall take effect and be in force
11 from and after its passage and approval by the Mayor and its publi-
12 cation; otherwise it shall take effect at the time it shall become
13 an ordinance under the law.
