ORDINANCE NO. 130.

AN ORDINANCE Providing for the purchase of a certain portion of the East Half (E $\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$) of Section Seventeen (17), Township Twenty-five (25), Range Five (5) East, W. M., King County, Washington, from The City of Seattle, Washington, for a sum not exceeding One Thousand One Hundred Fourteen (\$1,114.00) Dollars, as a part of the lands to be acquired for the Kirkland Waterworks system, and providing for the payment therefor from the proceeds of the sale of general bonds of The Town of Kirkland in the amount of Eighteen Thousand Two Hundred Fifty (\$18,250.00) Dollars, as provided for in Ordinance No. 116 of said Town.

WHEREAS, heretofore the Town Council of the Town of Kirkland duly passed Ordinance No. 116, approved October, 20, 1913, specifying and adopting a plan or system of constructing waterworks for said town, including certain lands and rights of way therefor, and providing for the issuance and sale of general coupon bonds of said Town in an amount not exceeding Eighteen Thousand Two Hundred Fifty (\$18,250.00) Dollars, to provide money therefor, and

WHEREAS, pursuant to said Ordinance No. 116, a special election was held in said Town, on said proposition on November 15, 1913, at which election said proposition was duly ratified and confirmed by a sufficient three-fifths ($\frac{3}{5}$) majority vote, and

WHEREAS, the lands described in Section 1 of this ordinance are a part of the lands so authorized to be acquired for such purpose and are necessary therefor, and

WHEREAS, The City of Seattle, owner of such lands, is willing to sell the same for cash for the sum of One Thousand One Hundred Fourteen (\$1,114.00) Dollars, and

WHEREAS, it is deemed for the best interest of the Town of Kirkland that such purchase be made, now, therefore,

Be it ordained by the Council of the Town of Kirkland as follows:

Section 1. That the following described lands, to-wit:

Beginning at a point 305.60 feet North 1° 02' 30" West of the Southwest corner of the Southeast Quarter (SE $\frac{1}{4}$) of the Southeast Quarter (SE $\frac{1}{4}$); thence North 89° 06' 45" East, a distance of four hundred forty-eight and forty-one hundredths (448.41) feet; thence North 1° 02' 30" West a distance of One Thousand Eighty-seven and fifty four hundredths (1087.54) feet; thence South 89° 08' 13" West, a distance of Four Hundred Forty-eight and forty-one hundredths (448.41) feet; thence South 1° 02' 30" East, a distance of One Thousand Eighty-seven and Seventy-three Hundredths (1087.73) feet to the point of beginning, all in the East Half (E $\frac{1}{2}$) of the Southeast Quarter (SE $\frac{1}{4}$) of Section Seventeen (17), Township Twenty-five (25), Range Five (5) East, W. M., and containing eleven and fourteen hundredths (11.14) acres more or less.

And the same are, hereby purchased and acquired from The City of Seattle for the sum of One Thousand One Hundred Fourteen (\$1,114.) Dollars cash.

Sec. 2. That the Mayor and Town Clerk are hereby authorized, empowered and directed to draw, and the Town Treasurer to pay, a warrant of the Town of Kirkland payable from the proceeds of the sale of General bonds authorized under Ordinance No. 116 as aforesaid, in favor of the City Treasurer of Seattle, in payment for said lands, upon approval of the title thereto, free and clear of all incumbrances, by the Town Attorney and the delivery of good and sufficient deed thereto vesting such title in the Town of Kirkland.

Sec. 3. This ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
