ORDINANCE NO. 134

1 AN ORDINANCE regulating the use and occupation of and the conduct  
2 of persons in and upon streets, avenues, ways, boulevards, drives  
3 public places and wharves, and rights of way open to the use of the  
4 public, and providing penalties for violations thereof.

5 BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KIRKLAND, as follows;

6 Section 1. It shall be unlawful for any person to ride, drive or  
7 propel an automobile, auto cycle or other motor vehicle along, over  
8 or through any public place, street, boulevard or drive in the Town  
9 of Kirkland at a greater rate of speed than ten (10) miles per hour  
10 within that certain district in the Town of Kirkland, toowit,  
11 within three hundred (300) feet of the water approach to the dock  
12 or steamboat landing known as the King County Dock, or at a greater  
13 rate of speed than fifteen (15) miles per hour along, on, through  
14 or over any other public place within the limits of the Town of  
15 Kirkland, ~~or pass or cross any street intersection~~ or round any  
16 corner within either of the districts in this section described, at  
17 a greater rate of speed than ten (10) miles per hour.

18 Section 2. It shall be unlawful for any person to ride, drive  
19 or propel any automobile, auto cycle or other motor vehicle without  
20 having attached thereto a bell, gong, horn or whistle in good working  
21 order and sufficient to give warning of the approach of such machine  
22 or vehicle, or to fail or neglect to sound such device as a warning  
23 when necessary upon approaching any carriage, automobile, auto cycle  
24 or other vehicle, or any pedestrian or upon approaching any street  
25 intersection or before passing around any corner on any street or  
26 public highway in the Town of Kirkland.

27 Section 3. Any person who shall violate or fail to comply with  
28 any of the provisions of this ordinance shall be deemed guilty of a  
29 misdemeanor, and upon conviction thereof shall be punished by a fine  
30 in any sum not exceeding Fifty (\$50.00) Dollars, or by imprisonment  
31 in the Town jail or in the County jail of King County, for a term

1 not exceeding fifteen (15) days, or by both such fine and imprison-  
2 ment, in the discretion of the court.

3 Section 4. This ordinance shall take effect and be in force  
4 from and after its passage and approval by the Mayor and its publi-  
5 cation as required by law.
