ORDINANCE NO. 137

AN ORDINANCE providing for the improvement of Waverly Street

from the intersection of Market and Waverly Streets, running north-  
westerly along the north side of Waverly Street to a point opposite

to west corner of Block (6) six

with a four (4) foot plank walk on the north side thereof, and doing  
such other work as may be necessary in connection therewith, all in  
accordance with plans prepared by the Town Engineer, and all in  
accordance with Resolution No. 20 of the Town Council of the

Town of Kirkland, and creating a local improvement district for such  
improvement, and providing that payment for said improvement be made  
by special assessments upon property in said district, payable by the  
mode of immediate payment.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KIRKLAND, as follows:

Section 1. That Waverly Street be improved from the intersection  
of Market and Waverly Streets running northwesterly along the north  
side of Waverly Street to a point opposite West Corner  
of Block (6) six with a four (4) foot  
plank side walk on the north side thereof, and that such other work  
be done as may be necessary in connection therewith, all in accord-  
ance with the plans and specifications therefor prepared under the  
direction of and by the Town Engineer and on file in the office of  
the Secretary of the Town Council of the Town of Kirkland.

Section 2. That the cost and expense of said improvement,  
including all necessary and incidental expenses shall be borne by  
and assessed against the property included in the assessment district  
hereinafter created in accordance with law. The Town of Kirkland  
shall not be liable in any manner for any portion of the cost and  
expense of said improvement except as herein provided.

Section 3. That there is hereby established a local improvement  
district to be called Local Improvement District No. 26,  
which said district is described as follows: All the property

1 between the termini of said improvement, to-wit, Waverly Street  
2 from its intersection with Market Street northwesterly to a point  
3 opposite the west corner of Block 6 six  
4 abutting upon, adjacent, vicinal or proximate to such portions of  
5 said streets and avenues to a distance back from the marginal lines  
6 thereof as provided by law.

7 Section 4. That the cost and expense of said improvement shall  
8 be defrayed by special assessments payable by the mode of immediate  
9 payment as defined by law and the Ordinances of the Town of Kirkland.  
10 Warrants bearing interest at the rate of ~~seven~~ (7%) per cent per annum  
11 until paid shall be issued to the contractor for the redemption of  
12 as many of the warrants issued on the local improvement district fund  
13 on estimates of the Town Engineer as may not be redeemed in cash.

14 Section 5. This ordinance shall take effect and be in force  
15 from and after its passage and approval by the Mayor and its publica-  
16 tion; otherwise it shall take effect at the time it shall become  
17 an ordinance under the law.
