

ORDINANCE NO. 147

1  
2 AN ORDINANCE providing for the improvement of Oxford Avenue  
3 commencing on the south line of Piccadilly Street, at the  
4 intersection of Piccadilly Street and Oxford Avenue; thence  
5 north along the East side of Oxford Avenue to the south line  
6 of Madison Street, by a four foot (4') plank walk on the East  
7 side thereof, and doing such other work as may be necessary in  
8 connection therewith, all in accordance with the plans pre-  
9 pared by the Town Engineer, all in accordance with Resolution  
10 No. 26 of the Town Council of the Town of  
11 Kirkland, and creating a Local Improvement District for such  
12 improvement, and providing that payment for said improvement  
13 be made by special assessments on the property of said District,  
14 payable by the mode of "Immediate Payment."

15 BE IT ORDAINED BY THE TOWN OF KIRKLAND, as follows:

16 Section 1: That Oxford Avenue, commencing on the south  
17 line of Piccadilly Street, at the intersection of Piccadilly Street  
18 and Oxford Avenue; thence north along the East side of Oxford  
19 Avenue to the South line of Madison Street, be improved by con-  
20 structing a four foot (4') plank walk on the East side thereof;  
21 and that such other work be done as may be necessary in connection  
22 therewith, according to the plans and specifications therefor pre-  
23 pared under the direction of, and by the Town Engineer, and on file  
24 in the office of the <sup>Clerk</sup> Secretary of the Council of the Town of Kirk-  
25 land.

26 Section 2: That the cost and expense of said improvement,  
27 including all necessary and incidental expenses shall be borne by  
28 and assessed against the property included in the assessment dis-  
29 trict hereinafter created, in accordance with law. The Town of  
30 Kirkland shall not be liable in any manner for any portion of the  
31 cost and expense of said improvement, except as herein provided.

Section 3: That there is hereby established a Local Improve-  
ment District to be called "Local Improvement District No. 27"  
which said District is described as follows: All the property be-  
tween the terminal of said improvement, to-wit: Commencing on the  
south line of Piccadilly street and Oxford Avenue, thence north

1 along the East side of Oxford Avenue to the south line of Madison  
2 Street, abutting upon, adjacent, vicinal, or proximate to such  
3 portions of said streets and avenues to a distance back from the  
4 marginal lines thereof, as provided by law.

5 Section 4: That the cost and expense of said improvement  
6 shall be defrayed by special assessments payable by the mode of  
7 "Immediate Payment", as defined by law, and the ordinance of the  
8 Town of Kirkland. Warrants bearing interest at the rate of 8 per  
9 cent per annum until paid, shall be issued to the contractor for  
10 the redemption of as many of the warrants issued on the Local Im-  
11 provement District Fund on estimates of the Town Engineer, as may  
12 not be redeemed in cash.

13 Section 5: This Ordinance shall take effect and be in  
14 force from and after its passage and approval by the Mayor and its  
15 publication; otherwise it shall take effect at the time it shall  
16 become an ordinance under the law.
