

ORDINANCE NO. 143

An ordinance providing for the improvement of street known as the State Aid Road NO.4.

Commencing on the centre line of Jackson Street, thence South along the State Aid Road No.4, to the Town limits, by a six foot plank walk on east side thereof, grading said street from the macadamized road to the East line of said street, and doing such other work as may be necessary in connection therewith; all in accordance with the plans prepared by the Town Engineer, all in accordance with Resolution No. 28 of the Town Council of the Town of Kirkland, and creating Local Improvement District for such improvement, and providing that payment for said improvement be made by special assessments on the property of said District payable by the mode of "Immediate Payment".

BE IT ORDAINED by the Town of Kirkland, as follows:

Section 1. That State Aid Road No.4, commencing on the centre line of Jackson Street, at the intersection of State Aid Road No.4 and Jackson Street, thence South along the State Aid Road No.4 to the Town limits, be improved by constructing a six foot plank walk on the East side thereof, and grading said street from the East side of the macadamized road to the East side of said street, and such other work be done as may be necessary in connection therewith, according to the plans and specifications therefor prepared under the direction of and by the Town Engineer, and on file in the office of the Clerk of the Council of the Town of Kirkland.

Section 2. That the costs and expenses of said improvements, including all necessary and incidental expenses shall be borne by and assessed against the property included in the assessment district hereinafter created, in accordance with law. The Town of Kirkland shall not be liable in any manner for any portion of the cost and expense of said improvement except as herein provided.

Section 3. That there is hereby established a Local Improvement District to be called "Local Improvement District No.28, which said

District is described as follows: All the property between the terminal of said improvement, to-wit: Commencing on the centre line of Jackson Street and State Aid Road No. 4, thence South along the East side of State Aid Road No. 4 to the Town limits of Kirkland, abutting upon, adjacent, vicinal, or approximate to such portions of said streets and avenues to a distance back from the marginal lines thereof, as provided by law.

Section 4. That the costs and expenses of said improvement shall be defrayed by special assessments payable by the mode of "Immediate Payment", as defined by law, and the ordinance of the Town of Kirkland. Warrants bearing interest at the rate of 8 per cent per annum until paid, shall be issued to the contractor for the redemption of as many of the warrants issued on the Local Improvement District Fund on estimates of the Town Engineer, as may not be redeemed in cash.

Section 5. This ordinance shall take effect and be in force from and after its passage and approval by the Mayor and its publication; otherwise it shall take effect at the time it shall become an ordinance under the law.
