An Ordinance providing for the improvement of Dale Street, commending on the South-line of Piccadilly Street at the intersection of Dale Street and Piccadilly Street, thence North on Dale Street to and graveling the centre line of Michigan Avenue, by grading said street, and a six foot board walk on the west side thereof, and doing such other work as may be necessary in connection therewith, all in accordance with the plans prepared by the Town Engineer, all in accordance with Resolution no. 30 of the Town Council of the Town of Kirkland, and creating Local Improvement District for such improvement, and providing that payment for said improvement be made by special assessments on the property of said District payable by the mode of "Immediate Payment".

BE IT ORDAINED by the Town of Kirkland, as follows:

Section 1. That Dale Street commencing on the South line of Piccadilly Street, at the intersection of Dale Street and Piccadilly Street, thence Forth on Dale Street to the centre line of Michigan and graveling.

Avenue, he improved by grading said street, and a six foot board walk on the West side thereof, and doing such, other work as may be necessary in connection therewith, ac ording to the plans and specifications therefor prepared under the direction of and by the Town Engineer, and on file in the office of the Clerk of the Council of the Town of Kirkland..

Section 2. That the costs and expenses of said improvements, including all necessary and incidental expenses shall be borne by and assessed against the property included in the assessment district hereinafter created, in accordance with law. The Town of Kirkland shall not be liable in any namer for any portion of the cost and expenses of said improvement except as herein provided.

Section 3. That there is hereby established a Local Improvement District to be called "Local Improvement District No.30", which said District is described as follows: All the property between the terminal of said improvement, to-wit: Commencing on the South line of Piccadilly Street at the intersection of Piccadilly Street and Dale Street, thence

North on Dale Street to the centre line of Michigan Avenue, abutting upon, adjacent, vicinal or approximate to such portions of said streets and avenues to a distance back from the marginal lines thereof, as provided by law.

Section 4. That the costs and expenses of said improvements shall be defrayed by special assessments payable by the mode of "Immediate Payment" as defined by law, and the ordinance of the Town of Kirkland.

Warrants bearing interest at the rate of 8 per cent per annum until paid, shall be issued to the contractor for the redemption of as many of the warrants issued on the Local Improvement District Fund, on estimates of the Town Engineer, as may not be redeemed in cash.

Section 5. This Ordinance shall take effect and be in force from and after its passage and approval by the Dayor and its publication; otherwise it shall take effect at the time it shall become an ordinance under the law.
