ORDINANCE NO. ~~148~~

An ordinance providing for the improvement of New Hampshire Avenue, State Aid Road, Jackson Street and Merle Street, by the laying of a four inch water main.

Beginning at Lake Avenue and running east up New Hampshire Avenue to the State Aid Road, thence north along the State Aid Road, to Jackson Street, thence west along Jackson Street to Lake Avenue. Also Merle Street east to the town limits, by the laying of a four inch water main, putting in hydrants and doing such other work as may be necessary in connection therewith; all in accordance with the plans prepared by the Town Engineer, all in accordance with Resolution No 34 of the Town Council of the Town of Kirkland, and creating Local Improvement District for such improvement, and providing that payment for said improvement be made by special assessments on the property of said district payable by mode of "Immediate Payment".

BE IT ORDAINED by the Town of Kirkland, as follows;

Section 1.

That beginning at Lake Avenue and running east up New Hampshire Avenue to the State Aid Road, thence north along the State Aid Road, to Jackson Street, thence west along Jackson Street to Lake Avenue. Also Merle Street east to the town limits, be improved by the laying of a four inch water main, the putting in of hydrants, and such other work as may be necessary in connection therewith, according to the plans and specifications thereof prepared under the direction of and by the Town Engineer and on file in the office of the Clerk of the Council of the Town of Kirkland.

Section 2.

That the costs and expenses of said improvements, including all necessary and incidental expenses shall be borne by and assessed

against the property included in the assessment district hereinafter created, in accordance with law. The Town of Kirkland shall not be liable in any manner for any portion of the costs and expense of said improvement except as herein provided.

Section 3.

That there is hereby established a Local Improvement District to be called "Local Improvement District No 32, which said District is described as follows: All of the property between the terminal of said improvement, to-wit: Beginning at Lake Avenue and running east up New Hampshire Avenue to the State Aid Road, thence north along the State Aid Road to Jackson Street, thence west along Jackson Street to Lake Avenue. Also Merle Street east to the town limits, abutting upon, adjacent, vicinal, or approximate to such portions of said streets and avenues to a distance back from the marginal lines thereof, as provided by law.

Section 4.

That the costs and expenses of said improvement shall be defrayed by special assessment payable by the mode of "Immediate Payment" as defined by law, and the ordinance of the town of Kirkland. Warrants bearing interest at the rate of 8 per cent per annum until paid, shall be issued to the contractor for the redemption of as many of the warrants issued on the Local Improvement District Fund on estimates of the Town Engineer, as may not be redeemed in cash.

Section 5.

This ordinance shall take effect and be in force from and after its passage and approval by the Mayor and its publication; otherwise it shall take effect at the time it shall become an ordinance under the law.
