

ORDINANCE NO. 153

An ORDINANCE providing for the improving of Lake Avenue, Central Avenue, Oxford Street, Moreton Avenue, by laying ^{or purchasing} of a water main.

Beginning at the south town limits, on Lake Avenue thence north, on Lake Avenue to Central Avenue on Central Avenue from Lake Avenue to Oxford Street, on Oxford Street, from Central Avenue to Moreton Avenue, on Moreton Avenue, from Oxford Street to a point just south of the water tank site, with a water main, putting in hydrants and doing such other work as may be necessary in connection therewith: all in accordance with the plans prepared by the Engineer, all in accordance with Resolution No 33 of the Town Council of the Town of Kirkland, and creating Local Improvement District No. 1 for such improvement, and providing that payment for said improvement be made by special assessment on the property of said district payable by mode of "Immediate Payment".

BE IT ORDAINED by the Town of Kirkland, as follows:-

Section 1.

That beginning on Lake Avenue at the south town limits, thence north on Lake Avenue to Central Avenue, thence east on Central Avenue to Oxford Street, thence north on Oxford Street, to Moreton Avenue, thence east on Moreton Avenue to a point south of the tank site, be improved by the laying ^{or purchasing} of a water main, the putting in of hydrants and such other work as may be necessary in connection therewith, according to the plans and specifications, thereof prepared under the direction of the Engineer and on file in the office of the Clerk of the Town Council of the Town of Kirkland.

Section 2.

That the costs and expenses of said improvements, including all necessary and incidental expenses shall be born by and assessed against the property included in the assessment district hereinafter created, to the extent it would cost to put in a four inch main, the balance of the cost to be born by the ~~the~~ Town of Kirkland, in accordance with law and the Ordinances of the Town of Kirkland. The Town of Kirkland shall not be liable in any manner, except for the excess cost over and above the cost of a four inch main, for any portion of the costs and expenses of

said improvements except as herein provided.

Section 3. That there is hereby established a Local Improvement District to be called "Local Improvement District No. 53." which said district is described as follows, to-wit: Beginning on Lake Avenue at the south town limits, thence north on Lake Avenue to Central Avenue, thence east on Central Avenue to Oxford Street, thence north on Oxford Street to Moreton Avenue, thence east on Moreton Avenue to a point south of the tank site, abutting upon, adjacent, vicinal, or approximate to such portions of said streets and avenues to a distance back from the marginal lines thereof, as provided by law.

Section 4.

That the costs and expenses of said improvement shall be defrayed by special assessment payable by the mode of "Immediate Payment" as defined by law, and the ordinance of the town of Kirkland. Warrants bearing interest at the rate of eight percent per annum until paid, shall be issued to the contractor for the redemption of as many of the warrants issued on the Local Improvement District Fund on estimates of the Town Engineer, as may not be redeemed in cash.

Section 5.

This ordinance shall take effect and be in force from and after its passage and approval by the Mayor and its publication; otherwise it shall take effect at the time it shall become an ordinance under the law.
