ORDINANCE NO. 155.

An Ordinance providing for the improvement of Picadilly Street, Oxford Street, Jefferson Avenue, Columbia Street, Fleet Street and Spring Street by the purchase wlaying off or constructing of a water main and the organization of a local improvement district and the preparation of an assessment roll for the same.

The said main to be (constructed) laid or purchased, being on Picadilly Street from Oxford Street east to the city limits; on Jefferson Avenue west to Columbia Street; thence northwesterly on Columbia Street to Fleet Street; thence southwesterly on Fleet Street to Spring Street; thence northwesterly on Spring Street to a point opposite the northern line of lot 10, block 22, Blewett's Addition to Kirkland; and hydrants to be placed and such other work as is necessary to be done, all in accordance with the recommendation of the Engineer of the Town of Kirkland and in accordance with Resolution No. 35 of the Town Council of the Town of Kirkland, and creating a local improvement district for such improvement and providing that payment for such improvement be made by special assessment on the property of said district payable by the mode of "immediate payment".

Be it ordained by the Town Council of the Town of Kirkland as follows:

Section 1. That Picadilly Street beginning at Oxford Real to the city limits, and and Jefferson Avenue west to Columbia Street, thence northwesterly on Columbia Street to Fleet Street, thence southwesterly on Fleet Street to Spring Street, thence northwesterly on Spring Street to a point

opposite the northern line of lot 10, block 22, Blewett's Addition to Kirkland, be improved by (constructing) laying or purchasing of a water main, the putting in of hydrants and such other work ar improvement as may be necessary in connection therewith, according to plans and specifications and recommendations prepared by the Town Engineer and on file in the office of the Clerk of the Town Council of the Town of Kirkland.

Section 2. That the cost and expense of such improvements, including all necessary and incidental expenses, shall be borne by and assessed against the property included in the assessment district (or local improvement district) hereinafter created. The Town of Kirkland shall not be liable in any manner for any portion of the cost of said improvement.

Section 3. That there is hereby established for the purposes in this ordinance, and especially in Section 2 herein, set forth, a local improvement district to be known as "Local improvement District No. 34", which said district is described as follows: Beginning on Picadilly Street from Oxford Street east to the city limits; on Jefferson Avenue west to Columbia Street; thence northwesterly on Columbia Street to Fleet Street; thence southwesterly on Fleet Street to Spring Street; thence northwesterly on Spring Street to a point opposite the northern line of lot 10, block 22, Blewett's Addition to Kirkland, and including all property abutting upon, adjacent, vicinal, or approximate to such portions of said streets to a distance back from the marginal lines there-of as provided by law.

That the cost and expense of such improvement shall be defrayed by special assessment payable by the mode of "immediate payment" as defined by law, and the ordinance of the Town of Kirkland, and at the recommendation of the Town Engineer warrants on the local improvement fund bearing interest at eight per cent will be issued in payment of such portion of the cost of said improvement as shall not be paid in cash.

Section 5. That the Town Engineer is hereby directed to prepare an assessment roll as required by law and the Clerk is directed to cause the same to be published and that Monday, October 18, 1915, at 8 o'clock p. m., is set for the time of hearing on the same, and all persons having objections to the said assessment roll be notified to file such objections in writing with the Town Clerk as required by law.

Section 6. This ordinance shall be in force and take effect from and after its passage and approval by the Mayor and its publication under the law.
