## ORDINANCE NO. 160

An ordinance amending Ordinance No. 150, entitled

"An Ordinance Providing Rules and Regulations Governing
the use of City Water by Citizens of the Town of Kirkland."

BE IT ORDAINED by the Town Council of the Town of Kirkland:

Sec. 1. That Section 2 of Ordinance No. 150 be and the same is hereby amended to read as follows:

Sec. 2. We person supplied with water from the town of Kirkland's mains will be entitled to use it for any purposes other than those stated in his application, or to supply in any way other persons or families.

The use of water for sprinkling or irrigating lawns, gardens, flowerspeds, plants, trees, shrubs, parking strips, or for hosing windows, woodwork, porches, steps or walks, is hereby prohibited except between the hours of six o'clock and eight o'clock A. M., and between five o'clock and senon o'clock P. M. No water user shall use water for sprinkling or irrigating except through one threequarter inch hose with a nozzle, the orfice of which is in no case greater than one-fourth of an inch in diameter, or in the place of such nozzle an automatic sprinker with no greater capacity than a nozzle one-fourth of an inch in diameter, and it shall be unlawful for any person to use water for sprinkling or irrigating through any other size of hose, nozzle or sprinkler, than as herein prescribed, or through any leaky or defective hose or through more than one set of hose, or through a hose with or without such nozzle or sprinkler attached at any time or times other than as herein authorized. Provided, the foregoing restrictions as to irrigating and sprinkling shall not apply to a metered service. And it shall be unlawful for any person to waste water or allow it to be wasted by imperfect or leaking stops, values, pipes, closets, faucets, or other fixtures, and it shall be unlawful for any person to use any water for irrigation or sprinkling during the progress of any fire in the town, except for the protection of property against fire.

If any person shall violate any provisions of this section, the Water commissioner shall shut off the water furnished to the premises, on which said violation occurs, and shall charge One Dollar (\$1.) for again turning on such water. And in any such case, the commissioner shall not again turn on such water until all unpaid and delinquent charges, and other charges, have been fully paid.

The town of Kirkland shall not be responsible for any service through or the maintenance of any water pipe or pipes that have not been laid by or under the direction and charge of the said town, and the said town of Kirkland shall not be liable for any damage of any kind or character whatsoever that may be sustained by amy person or any property by reason of the use of or service of water through any pipe or pipes not laid by the said town. In case any defect, leak or break shall develop in any water pipe or pipes not laid by or under the direction and charge of the said town, such defect, leak or break, shall be repair by and at the expense of those persons and property served through such pipe or pipes, and the water commissioner, in case of any such defect, leak or break developing in any such pipes, shall shut off the water until the same has been repaired, and in case the same is not repaired, the service through such pipes shall be discontinued.

Sec. 2. That Section 18 of Ordinance No. 150, be and the same is hereby amended to read as follows:

Sec. 18. All water bills, (other than metered service) shall be due and payable in advance on the first day of each month, and in case water bills are not paid on or before the 15th day of each month, a penalty of fifty cents shall be added to the bill. It shall be the duty of the water commissioner, from and after the fifteenth of the month, to cut off the water service from all property and premises for which the water bills have not been paid as herein provided.

The owner or occupant of any premises to which the water ser-

vice has been shut off, as herein provided, may have the service reinstated and the water turned on by paying up all delinquent water bills and the penalty herein provided, together with a charge of fifty cents for turning on the water and the payment of a month's rental in advance.

Sec. 3. This ordinance shall take effect and be in operation from and after its passage by the council and approved by the Mayor, and its publication.
