2 ORDINANCE NO. 164

4 AN ORDINANCE providing for the improvement of Lake Avenue,
5 Market Street, and Bond Street, by laying of water mains thereon
6 and creating Local Improvement District therefor, and providing
7 for the payment of said improvements by special assessment upon
8 the property in said District, all in accordance with Resolution
9 No. 48 of the Town Council of the Town of Kirkland, as follows:

10 BE IT ORDAINED By the Town Council of the Town of Kirkland,
11 as follows:

12 Sec. 1. That Lake Avenue, from the intersection of said
13 Lake Avenue with Central Street, to Market Street, and Market Street
14 from Lake Avenue to Picadilly Street, be improved by laying of a
15 six inch water main therein; and that Bond Street from Market
16 Street to the Northwest, to the intersection of Lake Avenue be
17 improved by laying of a four inch water main therein; and that
18 such other work be done as may be necessary in connection there-
19 with, according to the plans and specifications thereof prepared
20 under the direction of the Town Engineer.

21 Sec. 2. That the cost and expense of the laying of the said
22 four inch water main, and the proportionate cost of the laying of
23 the said six inch water main, equal to the cost of the laying of
24 the four inch water main, including all necessary and incidental
25 expenses, shall be borne and assessed against the property includ-
26 ed in the assessment district hereinafter created in accordance
27 with the law; and that that portion of the cost of the said six
28 inch water main in excess of the cost of the laying of said four
29 inch water main, shall be borne and paid out of the water fund.

30 Sec. 3. That there is hereby created a Local Improvement
31 District to be called Local Improvement District No. 38, which said
32 district is described as follows:

33 "All the property between the termini of said improve-
34 ment, abutting upon, adjacent or approximate to said
portion of said street to a distance back from the mar-
ginal lines thereof as provided by law."

Sec. 4. Warrants bearing interest at the rate of seven per-

6 NOTICE IS HEREBY GIVEN, that the assessment roll for local
7 Improvement District No. 38, under Ordinance No. 164, for the
8 improvement of Lake Avenue, Market Street and Bond Street, by the
9 laying of water mains therein, and such other work, as may be nec-
10 essary in connection therewith, according to the plans and speci-
11 fications thereof, prepared under the direction of the town
12 Engineer, is now on file at the office of the Town Clerk.

13 Said assessment roll has been set down for hearing at the
14 meeting of the Council to be held at eight o'clock P. M. at the
15 town Hall on the 19th day of ~~October~~, ^{March, 1917}, 1916, and all persons who
16 may desire to object to said assessment are notified to make such
17 objections in writing and to file the same with the Town Clerk
18 at or prior to the date fixed for such hearing. At the time and
19 place fixed and at such other times as the hearing may be contin-
20 ued to, the Council will sit as a board of equalization for the
21 purpose of considering such roll, and at such hearing or hearings,
22 will consider such objections made thereto, or any part thereof,
23 and will correct, revise, raise, lower, change or modify such
24 roll, or any part thereof, or set aside such roll and order that
25 such assessment be made de novo, as to such body shall appear just
26 and equitable, and then proceed to confirm same by ordinance.
