 AN ORDINANCE providing for the improvement of Lake Avenue, Market Street, and Bond Street, by laying of water mains thereon and creating Local Improvement District therefor, and providing for the payment of said improvements by special assessment upon the property in said District, all in accordance with Resolution No. 48 of the Town Council of the Town of Kirkland, and follows:

BE IT ORDAINED By the Town Council of the Town of Kirkland, as follows:

Sec. 1. That Lake Avenue, from the intersection of said
Lake Avenue with Central Street, to Market Street, and Market Street
from Lake Avenue to Picadilly Street, be improved by laying of a
six inch water main therein; and that Bond Street from Market
Street to the Northwest, to the intersection of Lake Avenue be
improved by laying of a four inch water main therein; and that
such other work be done as may be necessary in connection therewith, according to the plans and specifications thereof prepared
under the direction of the Town Engineer.

Sec. 2. That the cost and expense of the laying of the said four inch water main, and the proportionate cost of the laying of the said six inch water main, equal to the cost of the laying of the four inch water main, including all necessary and incidental expenses, shall be borne and assessed against the property included in the assessment district hereinafter created in accordance with the law; and that that portion of the cost of the said six inch water main in excess of the cost of the laying of said four inch water main, shall be borne and paid out of the water fund.

Sec. 3. That there is hereby created a Local Improvement District to be called Local Improvement District No. 38, which said district is described as follows:

"All the property between the terminiof said improvement, abutting upon, adjacent or approximate to said portion of said street to a distance back from the marginal lines thereof as provided by law."

Sec. 4. Warrants bearing interest at the rate of seven per-

cent per annum shall be issued in payment of the cost and expense of this improvement, which warrants shall be redeemed and paid by the collection of special assessments to be levied and assessed upon the property within the Local Improvement District provided for herein, said assessment to be immediately due and payable upon the hearing and confirmation of the assessment roll.

Sec. 5. This ordinance shall take effect and be in full force and effect from and after its passage and publication as provided by law.
