AN ORDINANCE providing for the improvement of Second Street by the laying of a four inch water main therein, and creating Local Improvement District therefor, and providing for the payment of said improvement by special assessment upon property in said district, all in accordance with Resolution No. \_\_\_\_\_\_\_\_ of the Town Council of the Town of Mirkland:

BE IT ORDAINED by the Town Council of the Town of Kirk-land, as follows:

Sec. 1. That Second Street, from the intersection of New Hampshire Avenue, South to the end of said Second Street, as now platted, be improved by the laying of a four-inch water main therein, and that such other work may be done as is necessary in connection therewith, according to the plans and specifications thereof prepared under the direction of the town engineer.

Sec. 2. That the cost and expense of the laying of said water main and all work in connection therewith, shall be borne and assessed against the property included in the assessment district hereinafter created in accordance with the law.

Sec. 3. That there is hereby created a Local Improvement District, to be called Local Improvement District No. 39
which said district is described as follows:

"All the property between the termini of said improvement, abutting upon, adjacent or approximate to said portion of said street to a distance back from the marginal lines thereof; as provided by law."

Sec. 4. That warrants bearing interest at the rate of seven percent per annum shall be issued in payment of the cost and expense of this improvement, which warrants shall be redeemed and paid by the collection of special assessments to be levied and assessed upon the property within the Local Improvement district provided for herein, said assessment to be immediately due and payable upon the hearing and confirmation of the assessment roll.

Sec. 5. This ordinance shall take effect and be in full force and effect from and after its passage and publication as provided by law.
