

ORDINANCE NO. 243

AN ORDINANCE PROVIDING FOR THE IMPROVEMENT OF Waverly Street between Park Street and the Alley which comes into Waverly Street at the South East corner of Lot 31 Block 7 Map of Kirkland, by grading and putting in cement sidewalks on the north side of said Waverly Street and such other work as may be necessary there- to including drains and a crossing at the intersection of Park Street and Waverly Street, all in accordance with resolution No. 102 of the Town Council of the Town of Kirkland, creating a local improvement district therefore, and providing that the payment of said local improvement be made by special assessment upon the property of said district payable by the mode of "Payment by Bonds."

THE TOWN COUNCIL OF THE TOWN OF KIRKLAND DOES HEREBY ORDAIN AS FOLLOWS:-

Section 1. That it will proceed to improve Waverly Street between Park Street and the Alley which comes into Waverly Street at the South East corner of Lot 31 Block 7 Map of Kirkland, by grading and putting in cement sidewalks on the North side of said Waverly Street and such other work as may be necessary in connection therewith, according to the plans and specifications therefor prepared under the direction of the Engineer in the employ of the Town of Kirkland on file in the office of the City Clerk.

Section 2. That the cost and expense of said improvement, including all necessary and incidental expenses, shall be borne and assessed against the property included in the assessment district hereinafter created in accordance with law. That the Town of Kirkland shall not be liable in any manner for any portion of the cost and expense of said improvement, except as herein provided.

Section 3: That there is hereby established a local improvement district to be called "Local Improvement District No. 72 which said

district is described as follows:

" All that property betweet the termini of said improvement immediately abutting upon that portion of the straat or other public place on the North side of Waverly Street between Park Street and the alley which comes into Waverly Street at the South East corner of Lot 31 Block 7 Map of Kirkland, as provided by law."

Section 4: Bonds bearing interest at the rate of 4 per cent per annum payable on or before 12 years from the date of issuance shall be issued in payment of the cost and expense of this improvement, which bonds shall be redeemed by the collection of special assessments to be levied and assessed upon the property within said district, payable in ten annual installments with interest at the rate of 4 per cent per annum under the mode of "Payment by Bond", as defined by law. These Bonds shall be delivered to the contractor in redemption of warrants on the Local Improvement District Fund issued on the estimates of the Town engineer, or the Town of Kirkland may, at its election, sell such bonds and make such redemption in cash.

Section 5: This ordinance shall be in full force and effect from and after its passage, approval and legal publication.

NOTICE OF HEARING ON ASSESSMENT ROLL.

Improvement of Waverly Street sidewalk, By L.I.D. No 72

Notice is hereby given that the assessment roll for Local Improvement District No. 72 for the improvement of Waverly Street between Park Street and the Alley which comes into Waverly Street at the South East corner of Lot 31 Block 7 Map of Kirkland, by putting in cement sidewalk on the North Side of said Waverly Street and such other work as may be necessary thereto including drains and crossing at the intersection of Park Street and Waverly Street, is now on file in the office of the Town Clerk.

Said roll has been set down for hearing at the regular meeting of the Town Council to be held in the Council Chambers in the Town of Kirkland at 8 o'clock P.M. on the 16th day of March, 1925, and all persons desiring to object to said assessment are notified to make such objections in writing and file the same with the Town Clerk at or prior to the date fixed for such hearing. At the time and place fixed and at such other times as the hearing may be continued to, the Council will sit as a board of Equalization for the purpose of considering such roll, and at such hearing, or hearings, will consider such objections made thereto, or any part thereof, and will correct, revise, raise, lower, change or modify such roll, or any part thereof, or set aside such roll and ^{that} order such assessment be made de novo, as to such body shall appear just and equitable, and then proceed to confirm same by ordinance.
