ORDINANCE NO. 244

AN ORDINANCE APPROVING AND CONFIRMING THE ASSESSMENT AND ASSESSMENT ROLL OF LOCAL IMPROVEMENT DISTRICT NO. 72FOR THE IMPROVEMENT OF Waverly Street between Park Street and the alley which comes
into Waverly Street at the South East corner of Lot 31 Block 7,
Map of Kirkland, in the Town of Kirkland, by grading and putting in
cement sidewalk on the North side of said Waverly street and such
other work as may be necessary thereto including drains and a crossing
at the intersection of Waverly street and Park street, under Ordinance
No. 243, and levying essessments and the amounts thereof against the
several lots, tracts, parcels of land and other property as shown on
said roll, and establishing a Local Improvement fund, and fixing the
date of the issuance of bonds.

Section 1: Let the assessment roll and assessment roll of Local Improvement District No 72 for the improvement of Waverly street between Park Street and the Alley which comes into Waverly Street at the South East corner of Lot 31 Block 7, Map of Kirkland, by grading and putting in cement sidewalk on the North side of said Waverly Street and such other work as may be necessary thereto inculding drains and a crossing at the intersection of Waverly street and Park Street, all in the Town of Kirkland, under Ordinance No. 243, as the same now stands be, and the same is hereby in all things approved and confirmed.

Section 2: That each of the lots, tracts, parcels of land and other property shown upon said roll is hereby a self to be specially benefitted by said improvement in at least the amount charged against the same and that the assessment appearing against the same is in proportion to the several assessments appearing on said roll. There is hereby levied and assessed against each such lot, tract, parcel of land or other property appearing upon such roll the amount finally charged against the same thereon.

Section 3: That for the purpose of this improvement there is hereby created and establis a special fund to be called Local Improvement Fund, District No.72.

Section 4: Bonds required to be issued for this improvement will be issued at the time provided by law.

Section 5: This ordinance will be in full force and effect after its passage and publication as required by law.
