

ORDINANCE NO. 245.

AN ORDINANCE providing for the improvement of Lake Avenue between Market street and the west side of Park street, by grading, gravelin and putting in proper cu;verts for drainage, and such other work as may be necessary thereto, all in accordance with Resolution No.105 of the Town of Kirkland creating local improvement district therefor

BE IT ORDAINED By the Town Council of the Town of Kirkland:-

Section 1: That Lake Avenue ~~be~~ from Market Street to the west side of Park street be improved by grading, graveling, putting in proper culverts, and such other work as may be necessary thereto, according to the plans and specifications of the Engineer in the employ of the said town.

Section 2: That the cost and expense of said improvement, including all necessary and incidental expenses shall be borne and assessed against the property included in the assessment districe hereinafter created according to law.

Section ~~3~~ 4: That there is hereby established a Local Improvement District to be called Local Improvement District No. 73, which said district is described as follows:-

" All property between the termini of said improvement abutting upon, adjacent or approximate to said portion said portion of said street to a distance back from ~~shad~~ marginal lines thereof as provided by law."

Section 3: Warrants bearing interest at the rate of 7 per cent. per annum shall be issued in payment of the cost and expense of said improvement, which warrants shall be redeemed and paid by the collection of special assessments to be levied and assessed against the property in the Local Improvement District provided for herein, said assessment to be immediately due and payable upon the hearing and confirmation of the assessment roll.

Section ~~5~~ 5: This ordinance shall be in full force and effect from and after its ~~and~~ passage and publication as provided by law.
