AN ORDINANCE specifying and adopting a system or plan for the making of additions and betterments to and extensions of the existing municipal water works system of the Town of Mirkland, declaring the estimated cost thereof, as near as may be, providing for the issuance and sale of \$15,000 general bonds of said Town to pay the cost thereof, and submitting the matter for ratification or rejection to the qualified voters of said Town at a special bond election, to be held therein on May 23, 1925.

WHEREAS, under and pursuant to the provisions of Ordinance No. 116 of the Town of Kirkland, Washington, there was submitted to the qualified voters of said town at an election held therein on November 15, 1913, the proposition of the acquisition by said town of a municipal water works system, and the proposition so submitted carried, and thereafter said town acquired said system and has at all times since owned, maintained and operated the same, and it is now necessary to make certain additions and betterments to and extensions of said system, in accordance with the system or plan therefor hereinafter set forth;

NOW, THERMFORE, BE IT ORDAINED by the Council of the Town of Hirkland:

SECTION I. The said Town of Kirkland and its corporate authorities hereby specify and adopt the system or plan hereinafter set forth for the making of said additions and betterments to and extensions of the existing municipal water works system of said town:

- 1. That for the purpose of protecting the existing source of supply from pollution and for increasing the source of supply, said town
  - (a) Acquire a parcel of land located in the S.W. of the S.E. & of Section 17, Township 25 Morth Range 5

E. W. M. King County, Washington, containing approximately 6.71 acres and particularly

described as follows:

Beginning on the base line of the Southwest of the Southeast North 39 deg. 28 min. 20 sec. West from Southeast corner 882.82 ft. to place of beginning, thence South 48 deg. 32 min. no sec. West 266.00 feet thence North 44 deg. 42 min. 10 sec. West 266.00 feet thence North 12 deg. 04 min. 10 sec. East 335.01 ft., thence North 53 deg. 29 min. 50 sec. East 360.84 ft. thence North 89 deg. 08 min. 13 sec. East 430.56 ft. thence South 46 deg. 29 min. 20 sec. West 327.26 ft. thence South 30 deg. 36 min. 30 sec. West 356.41 ft. thence South 39 deg. 55 min. 40 sec. East 125.80 ft. to place of beginning.

including any and all improvements thereon, all water arising thereon and the right to take and divert such water;

- (b) Clear about five acres of said land; and '
- (c) Construct thereon a concrete dam to impound, conserve and diverty such water.
- 2. That said town construct a new elevated tank of approximately gallons capacity on lands now belonging to said town, located at the Northwest corner of Jersey and Moreton Streets in said town, and also elevate the existing tank located on said lands.

The estimated cost of said system or plan is hereby declared, as near as may be, to be the sum of \$15,000.00.

SECTION 2. That in order to carry out said system or plan said town shall issue and sell its general negotiable coupon bonds in an amount not exceeding \$15,000, said bonds to bear interest not exceeding for per annum, payable semi-annually, and to be in such form denominations, and to bear such date, and to be payable at such place or places as the Town Council may by ordinance provide.

Said bonds shall mature serially in the order of their numbers, beginning with the second year after date of issue and ending twenty years after date of issue, and the various annual maturities shall (as nearly as practicable) be in such amounts as will, together with the interest on all outstanding bonds, be met by an equal annual tax levy for the payment of said bonds and interest. The life of the improvement to be acquired by the use of said bonds is hereby declared (as nearly as practicable) to be twenty years.

The proposition of making said additions and betterments to and extensions of the existing municipal water works system of said town, pursuant to the system or plan hereinabove specified and adopted, and the issuance of said bonds to pay the cost thereof shall be submitted to the qualified voters of said town for their ratification or rejection at a special bond election to be held in said town on May 23, 1925, and such proposition shall appear upon the ballot used at said election under the following ballot title:

SECTION 3. That the immediate acquisition of the lands hereinbefore described is

necessary to project from pollution the existing source of water supply of said town and that the immediate building of said dam is essential to furnish said town an adequate source of water supply, and the immediate construction of

said new tank and the remodeling of said existing tank are essential to provide adequate storage of water for domestic consumption and fire protection.

SECTION 4. That a real emergency exists for the holding of such election to authorize said improvements, which emergency is of force and character sufficient to impel said town to request the Election Board of King County, Washington, to call a special election to be held in said town on the date aforesaid for the purpose of submitting the aforesaid proposition to the qualified voters of said town for their ratification or rejection, and said town does hereby make such request to said Election Board.

SECTION 5. Notice of such election shall be given as required by law and the Town Council may by resolution designate the polling place in said town for such election, the officers of election and the form of notice of election.

SECTION 6. This ordinance shall be in full force and effect from and after its passage and approval and publication as required by law.
