

ORDINANCE NO. 256

AN ORDINANCE to regulate the keeping of domestic or wild fowls within the limits of the Town of Kirkland, and providing a penalty for the violation of this ordinance.

BE IT ORDAINED BY THE TOWN OF KIRKLAND AS FOLLOWS:

SECTION 1. That it shall be unlawful for any person, firm, company or corporation to permit any chickens, ducks, geese, turkeys, or other domestic or wild fowls belonging to them or under their control to run at large within the limits of the Town of Kirkland.

SECTION 2. Fowls, as above described, shall be deemed running at large within the meaning of this ordinance when off the owners premises and not within his immediate control.

SECTION 3. Any person, firm, company or corporation found violating any of the provisions of this ordinance shall <sup>deemed</sup> be/guilty of a misdemeanor and upon conviction thereof shall be fined not less than five (\$5.00) dollars nor more than fifty (\$50.00) dollars, or imprisonment in the Town jail for a term not to exceed thirty (30) days, or by both such fine and imprisonment within the discretion of the Court.

SECTION 4. This ordinance shall take effect and be in force from and after its passage, approval, and publication as required by law.
