ORDINANCE NO. 256

AN ORDINANCE PROVIDING for the amendment of Ordinance 247 of the Town of Kirkland.

Section 1. BE IT ORDAINED BY THE TOWN COUNCIL of the Town of Kirkland that Ordinance 247 of the Town of Kirkland be amended to read as follows: That Kirkland Ave. be improved from Lake Ave. to the City Limits on the North Side and from Blau's Chervolet Co/ garage property on the South Side to State Aid Road by putting in cement sidewalks and curbs; and the State Aid Road on the North and East Sides to the City limits by putting in cement sidewalks, with culverts and crossings and grading for the same; and Kirkland Ave. from Lake Ave. to the intersection of Kirkland Ave. and State Aid Road and the State Aid Road to the City Limits by grading, graveling, and proper drainage and such other work as may be necessary there to according to the plans and specifications of the Town Engineer now on file in the office of the Town Clerk.

Section 2. That the cost and expense of said improvement including the necessary and incidental expenses, shall be borne and assessed against the property included in the district hereinafter created according to law. The Town of Kirkland will not be ~~liable~~ liable for any portion of the cost and expense of said improvement, except as herein provided.

Section 3. That there is hereby created a Local Improvement District to be called Local Improvement District No . 74 which said district is described as follows:-

" All property between the termini of said improvement abutting upon, adjacent, vicinal or proximate to such portion of said streets and avenues to a distance back from the marginal lines thereof, as provided by law."

Section 4. That warrants bearing interest at the rate of 7% will be drawn on said improvement district and be payable from a fund to be known as Local Improvement District Fund No 74 which warrants shall be redeemed by the collection of ten annual instalments with interest at the rate of 7% plus 5% penalty if not paid on due date. These warrants shall be delivered to the contractor in payment for said work.

Section 5. This ordinance shall be in full force and effect from and after its passage, approval and legal publication.

It appearing from the records of this Town that the total number of voters voting in the said Municipality of Kirkland, at the general County or State election preceding this bond election, to-wit: The General County and State election held on November 4th, 1924, was 549, and it appearing from the canvass of the above bond election that the total vote cast upon said proposition was 300, which exceeds Fifty per cent of the said total number of voters voting in the Municipality of Kirkland, at the General County or State Election next preceding such election; and it further appearing from the canvass that the above proposition received the requisite number of votes, and is hereby declared to have carried.

Improvement of Waverly Street by L.I.D. NO.72 Ordinance 243
