

Ordinance 264

AN ORDINANCE AMENDING ORDINANCE NO. 258, OF THE TOWN OF KIRKLAND, FOR THE IMPROVEMENT OF Calhoun

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KIRKLAND

Section 1. That section 4 of Ordinance No. 258 be, and the same is hereby amended to read as follows: Section 4. That bonds bearing interest at the rate of seven per cent per annum payable on or before twelve years after date of issuance shall be issued in payment of the cost and expense of this improvement, which bonds shall be redeemed by the collection of special assessments against the property within said improvement district payable in ten equal annual instalments with interest at the rate of seven per cent per annum under the mode of "Payment by Bonds", as defined by law. These bonds shall be delivered to the contractor in redemption of the warrants on the local improvement district fund issued on the estimates of the Town Engineer, or the Town of Kirkland may, at its election, sell said bonds and make such redemption in cash.

CONTRACT.

THIS CONTRACT MADE AND ENTERED INTO this 6th day of October 1925, by and between the Town Of Kirkland, a municipal Corporation, party of the first part and Thos. E. VanCarnap, party of the second part.

WITNESSETH: That whereas, the party of the first part did on October 5th 1925 pass an Ordinance, No. 269, creating the office of garbage collector and specifying the regulations under which said garbage will be collected, which said Ordinance is hereby made a part of this contract by reference; the said party of the second part having been appointed Garbage Collector for the term of fifteen months from the first day of October, 1925, conditioned that he enter into a contract and furnish a good and sufficient bond for the faithful performance of his contract with the people of the Town of Kirkland and the said Town, it is mutually agreed between the parties hereto, in consideration of the covenants and mutual benefits to be derived from this contract, the said party of the second part covenants and agrees to and with the said party of the first part that he will collect the ~~garbage~~ garbage from the people of the Town of Kirkland with whom he contracts according to the terms of his agreement with the said people, and will furnish a bond to the Town of Kirkland in the sum of \$500.00 conditioned that he will perform his contract with the people ^{in accordance} and provisions of the said Ordinance.

This contract is for the term of fifteen months from the first day of October 1925
