

AN ORDINANCE approving and confirming the supplemental assessment and reassessment

^ roll of Local Improvement Reassessment District No. 74 for the improvements heretofore made by the Town of Kirkland, for the improvement of Kirkland Avenue from Lake Avenue to the city limits, and State Aid Road from the intersection of Kirkland Avenue and State Aid Road to city limits, by putting in cement sidewalks on Kirkland Avenue to the city limits on the north side, and from Blau Chevrolet Garage property on the south side to the intersection of Kirkland Avenue and State Aid Road, and State Aid Road from Kirkland Avenue on the north and east side to the city limits, and on the south and west sides from the intersection of State Aid Road and Kirkland Avenue to Jackson Street, together with curb and gutter, and by graveling and grading Kirkland Avenue from Lake Avenue to the city limits, and the State Aid Road from the intersection of Kirkland Avenue to the city limits, which said improvements were heretofore made under Ordinances Nos. 247, 256 and 261 of the Town of Kirkland, and which said supplemental assessment and reassessment roll has been made under the provision of Ordinance No. 290 of the Town of Kirkland, and levying and assessing the amounts thereof against the several lots, tracts, parcels of land and other property as shown on said roll, directing the payment of all amounts collected from said assessments into Local Improvement Fund District No. 74 heretofore established, and directing the delivery of said roll to the Town Treasurer for collection, and directing notice to be given of the collection of the said assessment, and ratifying and confirming the local improvement bonds heretofore issued by the Town of Kirkland, payable from Local Improvement Fund District No. 74.

BE IT ORDAINED by the Town of Kirkland as follows:

Section 1. That the supplemental assessment and reassessment roll of Local Improvement Reassessment District No. 74 for the improvement of Kirkland Avenue from Lake Avenue to the city limits, and State Aid Road from the intersection of Kirkland Avenue and State Aid Road to the city limits, by putting in cement sidewalks from Kirkland Avenue to the city limits on the north side, and from Blau Chevrolet Garage property on the south side to the intersection of Kirkland Avenue and State Aid Road, and State Aid Road from Kirkland Avenue on the north and east sides to the city limits, and on the south and west sides from the intersection of State Aid Road and Kirkland Avenue to Jackson Street, together with curb and gutter, and by graveling and grading Kirkland Avenue from Lake Avenue to the city limits, and the State Aid Road from the intersection of Kirkland Avenue to the city limits, which said improvements were heretofore made under Ordinances Nos. 247, 256 and 261 of the Town of Kirkland, and which said supplemental assessment and reassessment roll has been made pursuant to Ordinance No. 290 of the Town of Kirkland, ~~be~~, as the same now stands, and the same is hereby in all things approved and confirmed.

Section 2. That each of the lots, tracts, parcels of land and other property shown upon said roll is hereby declared to be specially benefited by said improvement in at least the amount charged against the same, and that the assessment appearing against the same upon the said roll is in proportion to the several assessments appearing upon said roll, and there is hereby levied and assessed against each such lot, tract or parcel of land or other property appearing upon said roll the amount finally charged against the same thereon.

Section 3. That Local Improvement Fund District No. 74 heretofore established for the said improvement is hereby designated and established as the fund into which all sums collected upon the said assessments shall be paid.

Section 4. The said supplemental assessment and reassessment roll shall be delivered to the Town Treasurer for collection and the said Town Treasurer is directed to give notice of the collection of said assessments, as provided by law, that the said roll is in his hands for collection and that any assessment thereon or any portion thereof **may** be paid at any time within thirty days from the date of the first publication of said notice without penalty, interest and costs, and that all sums remaining unpaid after the expiration of said thirty-day period may be paid in ten equal annual installments, together with interest thereon at the rate of seven per cent per annum, payable ~~semi~~-annually.

Section 5. That the local improvement bonds heretofore issued by the Town of Kirkland, payable out of the said Local Improvement Fund District No. 74, be and the same are now hereby ratified, approved and confirmed.

Section 6. This ordinance shall be in full force and effect from and after its passage, approval and publication, as required by law.
