ORDINANCE NO. 216

An Ordinance granting to UNION OIL COMPANY OF CALI-FORNIA, a corporation, permission to locate, construct, operate, maintain, repair, renew and remove pipe lines for the transportation of oils, fuels, water, and other liquid petroleum products therethrough, along, across, under and within lake Avenue and Jackson Street:

de hereby ordain as follows:

Section 1: That Union Oil Company of California, a corporation, is hereby given and granted the permission and right to locate, construct, lay down, operate, maintain, repair, renew and remove any number of pipes and pipe lines not exceeding live and of any size, not exceeding six (6). inches in internal diameter each, for the transportation of gesoline, distillate, kereosene, fuel oil, diesol, water and other fluids and liquids therethrough, in, along, across, under, through and within any portion of the entire width of Jackson Street extending the full length of Lot Six (6) in Block One (1) of Curtis Addition to the Town of Kirkland, and in, along, across, under, through, and within any portion of the entire width of Lake Avenue, extending the full width of Lots Five (5) and Siz (6) in Block One (1) of Curtis Addition to the Town of Kirkland, and the right to hereafter repair, replace, renew and remove said pipe lines at any time the same shall be necessary or convenient, said pipe lines to be buried nches under the surface of the to a depth of pertions of said streets that are now/used for general travel. Said supplemental and reassessment roll is made to pay for the improvement of Kirkland Avenue from Lake Avenue to the city limits, and State Aid Road from the intersection of Kirkland Avenue and State Aid Road to the city limits, by the putting in of cement sidewalks on Kirkland Avenue to the city limits on the north side and from Blau Chevrolet Garage property on the south side to the intersection of Kirkland Avenue and State Aid Road, and the State Aid Road from Kirkland Avenue on the north and east side to the city limits, and on the south and west side from the intersection of State Aid Road and Kirkland Avenue to Jackson Street, together with curb and gutter, and by grading and graveling Kirkland Avenue from Lake Avenue to the city limits, and the State Aid Road from the intersection of Kirkland Avenue to the city limits, as provided by Ordinance Nos. 247, 256 and 261 of said Town of Kirkland, and is levied pursuant to Ordinance No. <u>290</u> of said Town, passed and approved December <u>200</u>, 1926, providing for the making of such supplemental and reassessment roll; the boundaries of such reassessment district being as follows:
