

ORDINANCE NO. 369

AN ORDINANCE providing for and ordering a supplemental assessment upon the property embraced in Local Improvement District No. 73, directing the preparation of an assessment roll therefor.

WHEREAS the Town Council of the Town of Kirkland has heretofore ordered the improvement of Lake Avenue from Market Street to Park Street by grading, graveling, putting in proper culverts and such other work as may be necessary thereto under Ordinance No. 245 creating Local Improvement District No. 73; and

WHEREAS said improvement has been completed and accepted by said town; and

WHEREAS an assessment heretofore levied and confirmed against the property in said district for payment ~~for the pay-~~ment of the costs of said improvement; and

WHEREAS on account of the mistake and inadvertance the amount so assessed, being the sum of \$779.20 was not and is not sufficient to pay the total cost and expenses of the improvement so made and enjoyed by the owners of property in said Local Improvement District; and

WHEREAS the Town Council upon due investigation has determined and does hereby find and determine that the total deficiency in said assessment is the sum of \$ 274.73

NOW THEREFORE, BE IT ORDAINED By the Council of the Town of Kirkland, as follows:

Section 1. That a supplemental assessment is hereby ordered to be made against all of the property included in Local Improvement District No. 73 in an amount sufficient to take care of the deficiency in the original assessment against said district, said assessment to be made in accordance with the pro-

visions of the law and the ordinances existing at the time of the levy of such supplemental assessment. Provided: that such assessment shall be for an amount which, together with the original assessment, shall not exceed the actual cost and expense of the said improvement, together with the accrued interest thereon, it being the intent hereof to make said expense and cost of said Local Improvement payable by the property specially benefited thereby.

Section 2. That the Engineer for the Town of Kirkland be and they are hereby directed to prepare an assessment roll for such supplemental assessment which said roll shall include all property included in said Local Improvement District. Said assessment shall be made in accordance with the law and ordinances of said town and pursuant to the provisions hereof.

Section 3. When said assessment roll shall have been so prepared as herein ordered, the same shall be referred to the Town Council whereupon the Town Council shall fix a time for hearing ~~of~~ protests thereon, and the Town Clerk shall give due and regular notice of said hearing in the manner provided by law for original assessments.
