

Ordinance NO 391

AN ORDINANCE of the Town of Kirkland defining and regulating Barber shops and Barbers within the Town of Kirkland, requiring every Barbershop to obtain a permit therefor, fixing the fee for such permit, prescribing the hours of opening and closing of Barber Shops within the Town of Kirkland and providing a penalty for violation of this ordinance.

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KIRKLAND:

Section 1: That within the meaning of this Ordinance, the words (Barber or Barbering) shall include anyone shaving, cutting, shampooing or dressing the hair in any place where the work or business of a Barber or Barbering is done for pay: Provided the provisions of this Ordinance shall not apply to persons employed in, or engaged in the operation of any beauty shop or hair dressing establishment, operated exclusively for female persons, except as to cutting of hair in such establishments.

Section 2:- It shall be the duty of every person operating any barbershop within the limits of the town of Kirkland to comply with the rules and regulations prescribing sanitary requirements of barber shops by the State department of Licenses for barbers and barber shops, and to keep the said rules and regulations conspicuously posted therein. That the City Health Officer shall have the power to inspect all barber shops within the City limits for the purpose of ascertaining the sanitary conditions thereof, and to make his report to the proper authorities as to the sanitary condition therein.

Section 3: Any barber shop violating the aforesaid mentioned rules and regulations of the State department of Licenses, or any barber shop in which tools, appliances or furnishings in use therein are kept in an unclean and unsanitary condition so as to endanger health, then the proprietor or operator of such barber shop shall be guilty of a misdemeanor ^{be} and punished ^{ed} as in this ordinance provided.

Section 4: It shall be unlawful for any person, firm or corporation to operate any barber shop within the limits of the town of Kirkland until they have secured a license from the City Clerk with

a permit to show that they have paid a fee of One Dollar for each and every chair they operate for a period of One year.

Section 5: It shall be unlawful for any barber shop within the limits of the town of Kirkland to be open for business earlier than Eight O' clock A. M., nor shall any barber shop close later than ~~6:45~~ P.M. throughout the year, excepting on Saturday and preceeding legal Holidays, when they shall close not later than Nine O' clock P.M.

Section 6: Any person, firm or corporation, violating any of the provisions of this ordinance shall be guilty of a misdemeanor, and on conviction thereof, shall be fined in a sum of not less than five Dollars, nor more than Twenty five Dollars.

Section 7: This ordinance shall be in full force and effect from and after its passage, publication and approval as provided by law.
