ORDINANCE NO. 406.

An Ordinance amending Sections 3, 7, 8, 10 and 11 of Ordinance No. 231 of the Town of Kirkland, entitled, " An ordinance relating to the use of the public highways and all other places of the Town of Kirkland open to the public for the use of vehicles; providing penalties for the violation thereof, and repealing all ordinances and parts of ordinances in conflict therewith.", and adding ~~two~~ ^{and} new sections thereto to be known as sections 10a, 10b, ~~and 10c~~

BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF KIRKLAND as follows:-

Section 1. That section 3 of Ordinance No. 231 of the Town of Kirkland be amended so as to read as follows:

Section 3. No vehicle shall be stopped in such a manner as to bring the left side thereof next to the curb; and, no vehicle shall be parked on any street or highway of said Town so that the same shall extend more than 16 feet from the curb.

Section 2. That section 7 of said ordinance No. 231 be amended so as to read as follows:

Section 7. The following "No Parking" Zones are hereby created, and no vehicle shall be allowed to stand or be parked in any of the Zones hereby created, except for the purpose of loading or unloading, viz:

On the northwest corner of Lake Avenue and Kirkland Avenue, 14 feet northerly on the west side of Lake Avenue, and 21 feet westerly on the north side of Kirkland Avenue;

On the southwest corner of Lake Avenue and Kirkland Avenue, 14 feet southerly on the west side of Lake Avenue and 11 feet westerly on the south side of Kirkland Avenue;

On the southeast corner of Lake Avenue and Kirkland Avenue, 37 feet easterly on the south side of Kirkland Avenue and 42 feet southerly on the east side of Lake Avenue.

On the northeast corner of Lake Avenue and Kirkland Avenue 28

feet easterly on the north side of Kirkland Avenue, and 30 feet northerly on the east side of Lake Avenue;

On the southwest corner of Lake Avenue and Central Avenue, 26 feet southerly on the west side of Lake Avenue and 22 feet westerly on the south side of Central Avenue;

On the southeast corner of Lake Avenue and Central Avenue, 21 feet southerly on the east side of Lake Avenue;

On the north side of Central Avenue, a distance of 24 feet east from the north point of intersection thereof with the easterly line of Lake Avenue;

On the north side of Kirkland Avenue, a distance of 18 feet easterly from the east line of second street;

Provided, further, that no vehicle shall be allowed to stand or park in front of the entrance to or exit from any theatre at any time within 30 minutes before the time when the same is to be opened for the production of any show, or while such show is in progress; nor shall any vehicle be allowed to stand or park in front of the entrance to or exit from any garage or service station, while the same is open for the transaction of business.

Section 3. That section 8 of said ordinance No. 231, be amended so as to read as follows:

Section 8: No parking of vehicles shall be allowed on the pavement from the intersection of Market street and Fourth Avenue southerly ~~north westerly~~ to the intersection of Market street and Lake Avenue.

Section 4. That section 10 of said ordinance No. 231 be amended so as to read as follows:

Section 10. Upon the following designated portions of the following named streets of the Town of Kirkland, it shall be unlawful for any person to park any vehicle for any longer time or in any different manner than herein specified between the hours of 6 A.M. and 6 P.M., to wit:

On the east side of Lake Avenue from the southerly line of the present post office building, northerly to Central Avenue, vehicles

may be parked parallel to the curb for a period of not to exceed two hours at a time;

On the west side of Lake Avenue from the southerly line of the present Everest building, northerly to Central Avenue, vehicles may be parked diagonally to the curb for a period of not to exceed two hours at a time.

On the north side of Kirkland Avenue from the east line of Lake Avenue, easterly to Second street, vehicles may be parked diagonally to the curb for a period of not to exceed two hours at a time;

On the south side of Kirkland Avenue from Lake Avenue easterly to the projected west line of Second street, vehicles may be parked parallel to the curb for a period of not to exceed two hours at a time;

On the north side of Kirkland Avenue, from Lake Avenue westerly to the Taxi Zone, and on the south side of Kirkland Avenue westerly to the Stage Zone, vehicles may be parked diagonally to the curb for a period of not to exceed two hours at a time;

On the north side of Central Avenue from First street easterly to the end of the concrete pavement; and on the south side thereof from the first alley west of Lake Avenue, easterly to Lake Avenue, vehicles may be parked diagonally to the curb for a period of not to exceed two hours at a time.

Provided, however, that nothing herein contained shall be held or construed to permit the parking of vehicles in any "No Parking" Zone, as in this ordinance created.

Section 5. That there shall be added to said Ordinance No. 231 two new sections to be known as sections 10a and 10b, reading as follows:

Section 10a: No driver of a motor vehicle shall allow the engine thereof to be left running when the same is parked, unless there is some person in the same and in charge thereof;

Section 10b: No vehicle shall be parked on any street or highway of the Town of Kirkland, within the aforesaid Parking Zones unless

the same is parallel or diagonal to the curb, without any vehicle intervening between it and the curb without any vehicle intervening between it and the curb, so as to create the condition commonly called "double parking".

Section 6. That section 11 of said ordinance No. 231, be amended so as to read as follows:

Section 11: Any person who shall violate or fail to comply with the provisions of this ordinance shall be deemed guilty of a misdemeanor shall be ~~fined~~ punished by a fine of fifty cents for the first violation; and for a second or any subsequent violation shall be punished by a fine of not to exceed \$100.00, or by imprisonment in the Town jail for a term of not to exceed 30 days, or by both such fine and imprisonment.

Section 7. All ordinances and parts of ordinances in conflict herewith are hereby repealed.
