AN ORDINANCE PROVIDING FOR THE OFFICIAL RETAINING OF ATTORNEYS TO REPRESENT THE CITY OF KIRKLAND IN THE CONSTRUCTION OF A SEWER PROJECT IN THE KIRKLAND AND HOUGHTON AREA: APPROVING A CONTRACT HERETOFORE PROPOSED AND AGREED TO BY ATTORNEYS, HOMER GOLDBLATT, CHARLES W. JOHNSON, JR., MICHAEL KEYS COPASS AND CHARLES C. HALL, AND AUTHORIZING THE MAYOR AND CITY CLERK TO DO NECESSARY ACTS FOR THE EXECUTION OF SAID CONTRACT:

WHEREAS, the City of Kirkland is entering into the construction of a sewer project in the Kirkland and Houghton area, and

WHEREAS, in the construction of the said sewer project there will be various and numerous duties of a legal nature not within the scope of the duties of the regular retaining City Attorney of Kirkland, and

WHEREAS, Homer Goldblatt, Charles W. Johnson, Jr., Michael Keys Copass and Charles C. Hall, attorneys-at-law, have proposed and agreed to a certain contract of employment for the performance of legal services in connection with the said sewer project under date of <u>November 17th, 1941</u>, and

WHEREAS, it is to the best interest of the City of Kirkland to enter into an agreement with said parties.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KIRKLAND,

1. That Homer Goldblatt, Charles W. Johnson, Jr., Michael Keys Copass and Charles C. Hall, attorneys-at-law, be and they hereby are officially retained as attorneys to represent the City of Kirkland in the construction of the Kirkland-Houghton Sewer Project in accordance with the terms of a contract, dated <u>November 17,1941</u>, heretofore offered and agreed to by the said attorneys.

2. That the said parties are retained only for the particular work in connection with the Kirkland-Houghton Sewer Project, and the Contract of Employment offered and agreed to by the said attorneys is incorporated herein by reference and made a part of this Ordinance as though fully set forth herein; that all parties shall be remitted as to services and compensation strictly in accordance with the terms of the said Contract.

3. That the Mayor and the City Clerk be and they hereby are authorized and empowered to do all necessary acts essential to the completion of the said Contract and the carrying into effect of the provisions of this Ordinance.
