


ORDINANCENo. 481

AN ORDINANCE OF THE CITY OF KIRKLAND, DECLARING THAT THERE EXISTS A PUBLIC EMERGENCY OF THE CHARACTER ENUMERATED IN REMINGTON'S REVISED STATUTES, SECTION 9000-6, WHICH SAID EMERGENCY COULD NOT REASONABLY HAVE BEEN FORESEEN AT THE TIME OF MAKING THE BUDGET FOR 1943, AND APPROPRIATING THE SUM OF \$1014.55, AND AUTHORIZING IMMEDIATE EXPENDITURE OF SAID SUM FOR THE PURPOSE OF ACQUIRING, FOR THE USE OF THE CITY WATER DEPARTMENT IN AND FOR THE CITY OF KIRKLAND, A TRUCK.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

THAT WHEREAS an emergency exists which affects the health and welfare of the population of the City of Kirkland in that the Water Department in and for the City of Kirkland is without the use of truck facilities for the maintenance and operation of the Kirkland Water System, and

WHEREAS, said Water Department could not reasonably have foreseen that it would be deprived of such equipment in sufficient time to have duly advertised for bids for the acquisition of truck equipment for said use, and

WHEREAS, it is, in accordance with the ruling of the War Production Board, impossible for the City of Kirkland to acquire new truck equipment, and

WHEREAS, the virtual impossibility of acquiring satisfactory used truck equipment makes it necessary that the City Council of the City of Kirkland act at once in accepting an offer to sell to the City of Kirkland, immediately, used trucking equipment, and

WHEREAS, the expense for the acquisition of such equipment could not reasonably have been foreseen by the City Council of the City of Kirkland when the 1943 budget for the City of Kirkland was adopted, now, therefore,

THE CITY COUNCIL OF THE CITY OF KIRKLAND DOES HEREBY FIND that an emergency exists for the appropriation of the sum of Ten

Hundred Fourteen Dollars and Fifty-five Cents (\$1014.55) for the purchase of a used truck. There is hereby appropriated, for the City of Kirkland, the sum of Ten Hundred Fourteen Dollars and Fifty-five Cents (\$1014.55) to pay for said truck, and

IT IS FURTHER ORDAINED that said payment for said purpose be made forthwith.

This Ordinance is necessary for the preservation of health and welfare of the residents of the City of Kirkland and is hereby declared to be in full force and effect immediately.

Introduced, an emergency declared, and this Ordinance passed and approved this 18th day of January, 1943.
