AN ORDINANCE OF THE CITY OF KIRKLAND DECLARING THAT THERE EXISTS A PUBLIC EMERGENCY OF THE CHARACTER ENUMERATED IN REMINGTON REVISED STATUTES, SECTION 9000-6, WHICH SAID EMERGENCY COULD NOT REASONABLY HAVE BEEN FORSEEN AT THE TIME OF MAKING THE BUDGET FOR 1944, AND APPROPRIATING THE SUM OF \$1145.45, AND AUTHORIZING IMMEDIATE EXPENDITURE OF SAID SUM FOR THE USE AND BENEFIT OF THE CITY STREET DEPARTMENT IN AND FOR THE CITY OF KIRKLAND, FOR THE PURPOSE OF ACQUIRING CERTAIN STREET IMPROVEMENTS AND AUTHORIZING THE BORROWING OF SAID FUNDS FROM THE WATER DEPARTMENT IN AND FOR THE CITY OF KIRKLAND.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

THAT WHEREAS an emergency exists which affects the health and welfare of the population of the City of Kirkland in that the City of Kirkland is in immediate need of securing a street improvement on Central Avenue in said City along the block immediately east of Second Street in the nature of a macadam surface for said street, and

WHEREAS it is possible at this time for the City of Kirkland to secure the construction of said street improvement at a very economical cost in conjunction with certain hard-surfacing work now being performed upon the streets of the City of Kirkland, and

WHEREAS the Street Department could not reasonably have foreseen a need for said construction work at the time the budget for the year 1944 was prepared.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF KIRKLAND DOES HEREBY FIND that an emergency for the appropriation of the sum of Eleven Hundred Forty Five Dollars & Forty-five Cents (\$1145.45) for the construction of said hard surface on the street heretofore defined exists. There is hereby appropriated for the Street Department from the Water Department of the City of Kirkland the said sum of Eleven Hundred Forty Five Dollars & Forty-five Cents (\$1145.45) to pay for the cost of said construction.

IT IS FURTHER ORDAINED That in the budget for the year 1945 the City of Kirkland shall provide for the repayment to said City of Kirkland's Water Department said sum of Eleven Hundred Forty Five Dollars & Forty-five Cents (\$1145.45).

IT IS FURTHER ORDAINED That the payment of said sum for said purpose be made forthwith.

This Ordinance is necessary for the preservation of health and welfare of the residents of the City of Kirkland.

This Ordinance shall not be passed until one week after its introduction and shall require the unanimous vote of the Councilmen present and the approval of the Mayor.
