

ORDINANCE

No. 509

AN ORDINANCE OF THE CITY OF KIRKLAND DECLARING THAT THERE EXISTS A PUBLIC EMERGENCY OF THE CHARACTER ENUMERATED IN REM. REV. STATUTES, SECTION 9000-6, WHICH SAID EMERGENCY COULD NOT REASONABLY HAVE BEEN FORESEEN AT THE TIME OF MAKING THE BUDGET FOR 1945, AN APPROPRIATING THE SUM OF \$ 695.59, AND AUTHORIZING THE IMMEDIATE EXPENDITURE OF SAID SUM FOR THE USE AND BENEFIT OF THE CITY OF KIRKLAND FOR THE PURPOSE OF PAYING A GENERAL CONTRACTOR'S LIABILITY INSURANCE PREMIUM FOR SAID CITY OF KIRKLAND.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

THAT WHEREAS, an emergency exists which affects the health and welfare of the population of the City of Kirkland in that the City of Kirkland is in need of full contractor's general liability insurance coverage to protect said City of Kirkland from liability claims of all character, and

WHEREAS, said City Council of the said City of Kirkland has heretofore entered into an insurance contract for the purpose of so insuring the said City of Kirkland, and

WHEREAS, it could not have been reasonably foreseen at the time the 1945 budget was adopted for the City of Kirkland that said general contractor's insurance would be necessary or requisite,

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF KIRKLAND DOES HEREBY find that an emergency exists for the appropriation of the sum of \$ 695.59, for the payment of the said insurance premium. There is hereby appropriated from the General Fund of the City of Kirkland the said sum, for the purpose of paying said general liability insurance premium.

IT IS FURTHER ORDERED That the payment of said sum for said purpose be made forthwith.

This Ordinance is necessary for the preservation of health and for the welfare of the residents of the City of Kirkland.

This Ordinance shall not be passed until one week after its introduction and shall require the unanimous vote of the Councilmen present and the approval of the Mayor.
