AN ORDINANCE MAKING IT A MISDEMEANOR TO OPERATE A "BICYCLE" ON THE HIGHWAY OR STREETS WITHIN THE CITY LIMITS OF KIRKLAND WITHOUT HAVING PROPER BICYCLE REGISTRATION.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. It shall be unlawful for any person to operate any bicycle over and along any public highway or streets of this city, without first having obtained and having in full force and effect a current and proper bicycle license and display bicycle license number plate therefor as by this chapter provided

Section 2. Every bicycle license issued hereunder shall be valid until suspended, cancelled, or revoked as provided by law: Provided, that all bicycle licenses hereunder shall expire December 31st of each calendar year following the date of issue.

Section 3. "Bicycle". Every vehicle as herein defined having a saddle for the use of the rider operated by human power and designed to travel on not more than two wheels in contact with the ground.

Section 4. Bicycle license must be attached to the rear fender of said bicycle, and license must be clear at all times of mud or other obstructions so license plate can be plainly legible at all times.

Section 5. It shall be unlawful for any person to commit the following act:

- (a) To display or cause to permit to be displayed or have in possession any bicycle license knowing the same to be fictitious or to have been cancelled, revoked, or altered.
- (b) To lend or knowingly permit the use by one not entitled thereto any bicycle license issued to the person so lending or permitting the use thereof.
- (c) To display or represent as one's own, any bicycle license not issued to the person so displaying the same.
- (d) To fail or refuse to surrender to any court, peace or traffic officer upon demand any bicycle license, on notice that the same has been suspended, cancelled, or revoked as provided for herein.
- (e) To use a false or fictitious name or give a false or fictitious address in any application for a bicycle license or any renewal or duplicate thereof or knowingly to make a false statement or knowingly to conceal a material fact or otherwise commit a fraud in any such application.

Section 6. Except as otherwise specifically provided by ordinance for the licensing of bicycles, there shall be paid and collected annually for each calendar year or fraction part thereof, and upon each bicycle a license fee in the sum of Twenty-five Cents (.25).

Section 7. In event of a sale or other transfer to a new registered owner of any bicycle for which a bicycle license has been issued, the purchaser or transferee shall within ten days thereof apply to the Kirkland Police Department for a change in registration of bicycle license.

Section 8. The Police Department of the City of Kirkland will issue bicycle licenses and keep record of all bicycle licenses issued.

Section 9. The owner of any bicycle licensed in the City of Kirkland will produce upon demand of any city peace officer or city traffic officer or any city court, registration of his bicycle license.

Section 10. Any person violating the provisions of this Ordinance shall be guilty of a misdemeanor and upon conviction thereof shall be fined not to exceed \$25.00 plus costs.

Section 11. Said licenses shall be in such form as the Chief of Police shall from time to time establish.

Section 12. The Police Judge in and for the City of Kirkland is hereby authorized and empowered to revoke or suspend the licenses herein provided for on good cause shown.
