ORDINANCE

No. 534

AN ORDINANCE AMENDING CERTAIN PROVISIONS OF ORDINANCE NO. 463, BY PROVIDING A FEE FOR PLUMBING INSPECTION, A LICENSE FEE FOR MASTER PLUMBERS, AND A LICENSE FEE FOR JOURNEYMEN PLUMBERS.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

I

Section 12-14 of Ordinance No. 463 which provides as follows: "Before plumbing is installed on a premises, the owner shall be required to pay in to the city authorities a sum of Fifty Cents (\$.50) for a plumbing permit and after the work has been performed, an additional Fifty Cents (\$.50) for inspection thereof." is hereby repealed and in lieu thereof Section 12-14 shall be caused to read as follows:

Before plumbing is installed on any premises the owner or contractor shall be required to pay to the City Clerk the sum of Fifty Cents (\$.50) for each of the first six plumbing fixtures and the additional sum of Twenty-Five Cents (\$.25) each for each additional fixture.

II

Section 12-15 of said Ordinance No. 463 which provides as follows: "All master plumbers performing plumbing in the City of Kirkland shall secure a license before doing any plumbing work in the City of Kirkland. Said license shall be in the sum of Fifty Dollars (\$50.00), payable and due on January 2 of each year to the Treasurer of the City of Kirkland, except in the year 1942 the license shall be Twenty Five Dollars (\$25.00) payable on July 1, 1942. No journeyman plumber shall be permitted to repair, install or do plumbing work in the City of Kirkland unless he be in the employ of a regularly licensed Master Plumber. The license for journeymen plumbers shall be One Dollar Fifty Cents (\$1.50) each, payable on January 2 of each year, except in the year 1942, the license shall be One Dollar (1.00) payable on July 1, 1942."

is hereby repealed and in lieu thereof Section 12-15 shall be caused to read as follows:

"All master plumbers performing plumbing in the City of Kirkland shall secure a license before doing any plumbing work in the City of Kirkland. Said license shall be in the sum of Forty Dollars (\$40.00) payable and due on January 2 of each year to the Treasurer of the City of Kirkland, except in the year 1947, the license shall be Twenty Dollars (\$20.00) payable on the effective date of this ordinance. No journeyman plumber shall be permitted to repair, install or do any plumbing work in the City of Kirkland, unless he be in the employ of a regularly licensed Master Plumber. No license shall be issued to any journeyman plumber, unless the application therefore shall have been signed by the Master Plumber by whom said journeyman is employed, and said journeyman license shall continue in force and effect only so long as said journeyman remains in the employment of said Master Plumber. The license for journeyman plumber shall be One Dollar and Fifty Cents (\$1.50) each, payable on January 2 of each year, except in the year 1947. The license shall be One Dollar (\$1.00) from the effective date of this ordinance, until January 2, 1948. Each Master Plumber shall be required to deposit with the City Clerk of the City of Kirkland, a bond in the sum of One Thousand Dollars (\$1,000.00) conditioned upon his compliance with the plumbing code and ordinances of the City of Kirkland, as a pre-requisite to the issuance of any Master Plumber's license.
