

AN ORDINANCE ANNEXING CERTAIN TERRITORY ADJACENT TO THE CITY OF KIRKLAND AND LYING NORTHERLY THEREOF:

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. That that certain territory situate in King County, Washington, lying adjacent to the present boundaries of the City of Kirkland, and situate generally Northerly thereof, and described as follows, to-wit:

Beginning at the intersection of the South City limits of the City of Kirkland with the Inner Harbor Line of Lake Washington; thence Westerly along the production of the said City Limits to the Outer Harbor Line of said lake; thence Northerly along said outer Harbor Line to the North margin of Northeast 112th Street, produced Westerly; thence Easterly on the said North line of the Northeast 112th Street to the West margin of 98th Avenue N. E. thence Southerly on the West margin of 98th Avenue N. E., to the South margin of Northeast 106th Street; thence Easterly along the South margin of Northeast 106th Street to the West margin of 100th Avenue N. E.; thence Southerly along the West margin of 100th Avenue N. E., to the South margin of N. E. 104th Street; thence Easterly along the South margin of N. E. 104th Street to the West margin of 116th Avenue N. E.; thence Southerly along the West margin of 116th Avenue N. E., to the North margin of Northeast 100th Street; thence Westerly along the North margin of Northeast 100th Street; thence Easterly margin of the Northern Pacific Railroad right of way; thence Southerly along the Easterly margin of the said right of way to the Kirkland City Limits; thence Westerly along the said City Limits to the Inner Harbor Line; thence Southerly along the Inner Harbor Line to the point of beginning.

be and the same hereby is annexed to the City of Kirkland, and made a part thereof, pursuant to the Board of County Commissioners of King County, Washington, Resolution No. 10690 certifying that the proposition for the annexation of the afore-described territory has been duly submitted to the voters in said area on October 28, 1947, and was favorably voted on with thirty-eight (38) voting for annexation, and thirty-four (34) voting against annexation.
