AN ORDINANCE REGULATING THE KEEPING OF DOGS IN THE TOWN OF KIRKLAND, WASHINGTON, AMENDING ORDINANCE NO. 6 AND REPEALING ORDINANCE NO. 309.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

SECTION I, ORDINANCE NO. 6 of the Town of Kirkland, is hereby amended as follows:

1. SECTION II of said ordinance providing as follows: "The annual license fee for dogs is hereby fixed at One Dollar (\$1.00) for each male dog, and Two Dollars (\$2.00) for each female dog" is hereby repealed and said Section is caused to read as follows: The annual license for dogs is hereby fixed at One Dollar (\$1.00) for each male dog and for each spayed female dog and ^{Two} ~~Three~~ Dollars ^{2.00} ~~(\$3.00)~~ for each unspayed female dog.

2. SECTION VI of said ordinance No. 6, providing as follows: "Any owner or keeper of a dog so impounded may redeem the same within forty eight hours (48) after its impounding by paying to the Town Treasurer, the prescribed license fee, together with a penalty of One Dollar (\$1.00) and obtaining from the Town Clerk a license and Tag in the manner above prescribed; and upon presentation of such license and tag at the pound, the dog so impounded shall be released", is hereby repealed and said Section ~~VI~~ is hereby caused to read as follows: Any owner or keeper of a dog so impounded may redeem the same within forty eight hours (48) after its impounding by paying to the City Treasurer or City Clerk, for the benefit of the City Treasurer, the prescribed license fee and by further paying to the official Dog Catcher of the City of Kirkland, the sum of One Dollar Fifty cents (\$1.50) per day or fraction thereof, for each day or fraction thereof in which said dog has been held by said Dog Catcher. Upon presentation to said Dog Catcher of the license and tag at the dog pound and upon the payment of the aforementioned fee to said Dog Catcher, the dog so impounded shall be released by the Dog Catcher.

3. SECTION VII which reads as follows: "All moneys received from the sale and redemption of impounded dogs (except said license tax) shall be the property of ~~and~~ delivered to the said Marshall as reimburse-

ment and compensation for the care of such dogs while impounded. And it shall be the duty of such Marshall to cause all such dogs, while impounded, to be fed and treated in a humane manner", is hereby repealed and said Section is now caused to read as follows: "All moneys received from the sale and redemption of impounded dogs (except said license tags) shall be the property of and delivered to the Dog Catcher, officially appointed for the City of Kirkland, as reimbursement and compensation for the care of such dogs while impounded. And it shall be the duty of said Dog Catcher to cause all such dogs, while impounded to be fed and treated in a humane manner.

4. The City of Kirkland shall pay to the Dog Catcher, officially appointed, to act for said City of Kirkland, the sum of Two Dollars (\$2.00) for each dog lawfully killed by said Dog Catcher in the course of his duty, as Dog Catcher for the said City of Kirkland.

5. ORDINANCE NO. 309 of the City of Kirkland is hereby repealed EN TOTO, introduced this 16th day of February, 1948, passed and approved this ^{22nd} ~~15th~~ day of March, 1948.
