

ORDINANCE NO. 559

AN ORDINANCE APPROVING AND CONFIRMING THE FINAL ASSESSMENT AND ASSESSMENT ROLL OF LOCAL IMPROVEMENT DISTRICT NO. 93 FOR THE IMPROVEMENTS HERETOFORE MADE BY THE TOWN OF KIRKLAND BY THE CONSTRUCTION OF A COMPLETE STREET LIGHTING SYSTEM ON THE FOLLOWING DESCRIBED STREETS: CENTRAL WAY, FROM MARKET STREET TO THIRD STREET; LAKE STREET, FROM CENTRAL WAY TO KIRKLAND AVENUE; LAKE STREET SOUTH, FROM KIRKLAND AVENUE TO SECOND AVENUE SOUTH; FIRST AVENUE, FROM LAKE STREET TO THIRD STREET; SECOND STREET, FROM CENTRAL WAY TO KIRKLAND AVENUE; KIRKLAND AVENUE, FROM FERRY DOCK TO 721.50 FEET EAST OF THIRD STREET; THIRD STREET SOUTH, FROM KIRKLAND AVENUE TO SECOND PLACE SOUTH; AND, THE ALLEY WEST OF LAKE STREET IN THE KIRKLAND PARKING LOT; WHICH IMPROVEMENTS WERE HERETOFORE MADE UNDER ORDINANCES NO. 550, 555, and 557 OF THE CITY OF KIRKLAND, AND LEVYING AND ASSESSING THE AMOUNTS THEREOF AGAINST THE SEVERAL LOTS, TRACTS, PARCELS OF LAND AND OTHER PROPERTY AS SHOWN ON SAID ROLL DIRECTING THE PAYMENT OF ALL AMOUNTS COLLECTED FROM SAID ASSESSMENTS IN THE LOCAL IMPROVEMENT FUND DISTRICT NO. 93 HERETOFORE ESTABLISHED, AND DIRECTING THE DELIVERY OF SAID ROLL TO THE TOWN TREASURER FOR COLLECTION, AND DIRECTING NOTICE TO BE GIVEN OF THE COLLECTION OF SAID ASSESSMENT AND ACCEPTING THE WORK AS COMPLETED AND RATIFYING AND CONFIRMING THE LOCAL IMPROVEMENT WARRANTS HERETOFORE ISSUED BY THE CITY OF KIRKLAND PAYABLE FROM LOCAL IMPROVEMENT FUND DISTRICT NO. 93.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. That the final assessment and assessment roll of Local Improvement District No. 93 for the improvement of the business area of Kirkland on the following described streets, to-wit:

Central Way, from Market Street to Third Street;

Lake Street, from Central Way to Kirkland Avenue;

Lake Street South, From Kirkland Avenue to Second Avenue South;

First Avenue, from Lake Street to Third Street;

Second Street, from Central Way to Kirkland Avenue;

Kirkland Avenue, from Ferry Dock to 721.50 feet East of Third Street;

And, the alley West of Lake Street in the Kirkland parking lot;

by the construction of a complete street lighting system, together with light standards, wiring, switches, globes and all necessary appurtenances thereto, in accordance with the plans and specifications as prepared by H. H. Sisler, Consulting City Engineer of the City of Kirkland, under Ordinance No. 550 of the City of Kirkland, and under Ordinances 555, and 557, be as the same now stands and the same is hereby in all things approved and confirmed.

Section 2. That each of the lots, tracts, parcels of land and other property shown upon said roll is hereby declared to be specially benefited by said improvement in at least the amount charged against the same, and

that the assessment appearing against the same upon the said roll is in proportion to the several assessments appearing upon said roll, and there is hereby levied and assessed against each lot, tract, parcel of land or other property appearing upon said roll the amount finally charged against the same thereon.

Section 3. That Local Improvement Fund District No. 93 heretofore established for the said improvement is hereby designated and established as the fund into which all sums collected upon the said assessments shall be paid.

Section 4. The said final assessment and assessment roll shall be delivered to the Town Treasurer for collection, and the said Town Treasurer is directed to give notice of the collection of said assessments as provided by law; that the said assessment roll is in his hands for collection and that any assessment thereon or any portion thereof may be paid at any time within thirty (30) days from the date of the first publication of said notice without penalty, interest or costs, and that all sums remaining unpaid after the expiration of said thirty (30) day period may be paid in ten (10) equal annual instalments together with interest thereon at the rate of 6 per cent per annum payable annually. Any installment not paid prior to the expiration of the thirty (30) day period during which such installment is due and payable shall thereupon become delinquent. All delinquent installments shall, until paid, be subject to a charge of interest at the rate of 6% per annum and to an additional charge of 5% penalty, levied upon both principal and interest due upon such installment or installments from the date of delinquency.

Section 5. That the said improvement as hereinbefore set forth, be considered complete and the same be accepted by the City of Kirkland upon approval by the City's Consulting Engineer and that the warrants heretofore issued payable out of the said Local Improvement Fund District No. 93 be and the same now are ratified, approved and confirmed.

Section 6. This ordinance shall be in full force and effect from and after its passage, approval and publication as required by law.
