## ORDINANCE NO. 572

AN ORDINANCE OF THE CITY OF KIRKLAND RELATING TO THE MUNICIPAL SEWER SYSTEM, PROVIDING FOR AND ESTABLISHING CHARGES FOR THE CONNECTION OF SEWERS AND REPAIR OF STREETS IN CONNECTION THEREWITH, AND FURTHER, ABOLISHING DISCOUNTS FOR THE PAYMENT OF MONTHLY CHARGES ON OR BEFORE THE 15TH DAY OF EACH CALENDAR MONTH, AND PROVIDING FOR A LIEN FOR FAILURE TO PAY THE RATES AND CHARGES PROVIDED FOR.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

## Section 1.

That for the connection of any sewer lines to the municipal sewer system, the City of Kirkland shall charge the sum of \$25.00 for such connection and the repair of any street in connection therewith. There shall be no charge for connection by user made at time original sewer line is installed.

## Section 2.

That hereafter there shall be no discount allowed for the payment of any monthly service charges on or before the 15th day of the month in connection with any sewer service of the City of Kirkland. If payment for said service charge by any user is made later than the 15th day of the calendar month an additional twenty-five cents (25¢) will be required for delinquent payment.

## Section 3.

All charges for connections and for sewerage service provided for in this Ordinance, together with penalties and interest thereon, shall be a lien upon the property with which such connection is made or sewerage service rendered respectively, superior to all other liens and incumbrances whatsoever except for general taxes and local and special assessments. The City Clerk is hereby authorized and directed prior to the expiration of six months from the first day of the first month for which such charges were unpaid, to certify to the Auditor of King County all of such charges as a lien upon such property in the manner provided for in Chapter 193 of the Washington Session Laws of 1941, and such property shall be subject to foreclosure pursuant to the terms of said chapter.

## Section 4.

That all other fees, charges, and services relating to the sewer system of the City of Kirkland shall be and remain as heretofore fixed and established by Ordinance, Resolution or Statute.

Section 5.

This Ordinance shall be in force and take effect five days from and after its passage by the council, its approval by the Mayor, and its publication according to law.
