ORDINANCE NO. 589

AN ORDINANCE OF THE CITY OF KIRKLAND AMENDING ORDINANCE NO. 569 OF THE CITY OF KIRKLAND BY THE ADDITION OF MINIMUM RATES FOR 8" METERS INSIDE AND OUTSIDE THE CORPORATE BOUNDARY LINES OF THE CITY OF KIRKLAND OF \$40.00 INSIDE THE CITY, AND \$50.00 OUTSIDE THE SAID CITY BOUNDARIES.

WHEREAS, it appears that Ordinance No. 569 of the City of Kirkland related to the municipal water system in the City of Kirkland failed to include or provide minimum rates for 8" meters either inside or outside of the corporate boundary lines, now, therefore,

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. That Section 11, Meter Rates, of Ordinance No. 569, be and the same hereby is repealed.

Section 2. That Section 11, Meter Rates, of Ordinance No. 569, shall read and be as follows:

Section 11, Meter Rates:

The following schedule of rates shall apply to customers inside the corporate boundary lines of the City of Kirkland:

First 1000 cubic feet or less	\$ 1.75
Next 10,000 cubic feet per 100 cubic feet	.10
All water over 11,000 cubic ft. per 100 cubic feet	.05

These prices pertain to 1/2 and 3/4 meters only.

The following minimum rates on meters will be charged:

1" meter	\$ 2.00
1 1/4" meter	2.25
1 1/2" meter	2.50
2 " meter	4.00
3 " meter	6.00
4 " meter	10.00
5 " meter	14.00
6 " meter	25.00
8 " meter	40.00

Apartment Rates on 1/2 and 3/4 Meters:

Duplex - \$3.00 Minimum

Apartments - \$3.00 plus 50¢ for each unit

Cabin Courts - \$3.00 plus 50¢ for each unit

For larger meters add difference between standard rates and 1/2 and 3/4 to \$3.00 Minimum.

Outside of the corporate boundary lines of the City of Kirkland the following rates will prevail:

First 1000 cubic feet or less	\$ 2.25
Next 10,000 cubic feet per 100 cubic feet	.15
Over 11,000 cubic feet per 100 cubic feet	.7½

These prices pertain to 1/2 and 3/4 meters only.

The following minimum rates on meters will be charged:

1" meter	3.00
1¼" meter	3.25
1½" meter	3.50
2 " meter	5.00
3 " meter	7.50
4 " meter	12.00
5 " meter	18.00
6 " meter	30.00
8 " meter	50.00

Apartment Rates on 1/2 and 3/4 Meters:

Duplex - \$4.00 Minimum

Apartments - \$4.00 plus 50¢ for each unit

Cabin Courts - \$4.00 plus 50¢ for each unit

For larger meters add difference between standard rates and on 1/2 and 3/4 to \$4.00 Minimum.

Section 3. This Ordinance is intended to amend Ordinance No. 569 by the addition of Meter Rates for 8" Meters inside and outside the City Limits as above set forth and is not intended to in any manner repeal or alter Ordinance No. 569 or other Ordinances of the City of Kirkland except as set forth herein.

This Ordinance shall take effect from and after five days after the date of its publication.
