AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, REPEALING ORDINANCE NO. 604; AND AMENDING SECTION 11 OF ORDINANCE NO. 569; ESTABLISHING NEW WATER SERVICE CHARGES EFFECTIVE SEPTEMBER 1, 1951, STARTING WITH A MINIMUM INSIDE THE CITY LIMITS OF TWO DOLLARS AND FIFTY CENTS (\$2.50) FOR ONE THOUSAND (1000) CUBIC FEET OF WATER WITH EXCESS AT TEN CENTS (10¢) PER ONE HUNDRED (100) CUBIC FEET AND A MINIMUM OUTSIDE THE CITY LIMITS OF THREE DOLLARS AND FIFTY CENTS (\$3.50) FOR ONE THOUSAND (1000) CUBIC FEET OF WATER WITH EXCESS AT FIFTEEN CENTS (15¢) PER ONE HUNDRED (100) CUBIC FEET; AND FIXING CHARGES FOR LARGER METERS; AND CREATING A FIFTY DOLLAR (\$50.00) CHARGE PAYABLE AT THE TIME OF WATER CONNECTION FOR ALL NEW CONNECTIONS TO THE KIRKLAND WATER SYSTEM OR LINES OWNED BY THE CITY OR OVER WHICH THE CITY HAS JURISDICTION.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1.

That Ordinance No. 604 of the City of Kirkland be and the same hereby is repealed.

Section 2.

That Section 11 of Ordinance No. 569 which reads as follows:

"Section 11. METER RATES:

The following schedule of rates shall apply to customers inside the corporate boundary lines of the City of Kirkland:

First 1000 cubic feet or less - - - - -	\$1.75
Next 10,000 cubic feet per 100 cubic feet -	.10
All water over 11,000 cubic ft. per 100 cubic feet -	.05

These prices pertain to 1/2 and 3/4 meters only.

The following minimum rates on meters will be charged:

1 " meter - - - - -	2.00
1 1/2 " meter - - - - -	2.25
1 3/4 " meter - - - - -	2.50
2 " meter - - - - -	4.00
3 " meter - - - - -	6.00
4 " meter - - - - -	10.00
5 " meter - - - - -	14.00
6 " meter - - - - -	25.00

Apartment Rates on 1/2 and 3/4 Meters:

Duplex - - - - -	\$3.00 Minimum
Apartments - - - - -	\$3.00 plus 50% for each unit
Cabin Courts - - - - -	\$3.00 plus 50% for each unit

For larger meters add difference between standard rates and 1/2 and 3/4 to \$3.00 Minimum.

Outside of the corporate boundary lines of the City of Kirkland the following rates will prevail:

First 1000 cubic feet or less - - - - -	\$2.75
Next 10,000 cubic feet per 100 cubic feet - -	.15
Over 11,000 cubic feet per 100 cubic feet - -	.07

These prices pertain to 1/2 and 3/4 meters only.

The following minimum rates on meters will be charged:

1 " meter - - - - -	\$ 3.00
1 1/2 " meter - - - - -	3.25
1 3/4 " meter - - - - -	3.50
2 " meter - - - - -	5.00
3 " meter - - - - -	7.50
4 " meter - - - - -	12.00
5 " meter - - - - -	18.00
6 " meter - - - - -	30.00

Apartment Rates on 1/2 and 3/4 Meters:

Duplex - - - - -	\$ 4.00 Minimum
Apartments - - - - -	4.00 plus 50% for each unit
Cabin Courts - - - - -	4.00 plus 50% for each unit

For larger meters add difference between standard rates and on 1/2 and 3/4 to \$4.00 Minimum. " be and the same

hereby is repealed and re-enacted to read as follows:

Section 11. Water Rates

The following schedule of rates shall apply to customers inside the corporate boundary lines of the City of Kirkland:

First 1000 cubic feet or less- - - - -	\$ 2.50
Next 10,000 cubic feet per 100 cubic feet -	.10
All water over 11,000 cubic ft. per 100 cubic feet	.05

These prices pertain to 1/2 and 3/4 meters only.

The following minimum rates on meters will be charged:

1 " meter - - - - -	\$ 2.75 + 50% = 4.125
1 1/2 " meter - - - - -	3.00
1 3/4 " meter - - - - -	3.25
2 " meter - - - - -	4.00
3 " meter - - - - -	6.00
4 " meter - - - - -	10.00
5 " meter - - - - -	14.00
6 " meter - - - - -	25.00

Apartment Rates on 1/2 and 3/4 Meters:

- Duplex - - - - - \$ 3.00 Minimum *+ 50%*
- Apartments - - - - - 3.00 plus 50% for each unit
- Cabin Courts - - - - - 3.00 plus 50% for each unit

For larger meters add difference between standard rates and 1/2 and 3/4 to \$3.00 Minimum.

Outside of the corporate boundary lines of the City of Kirkland the following rates will prevail:

- First 1000 cubic feet or less - - - - - \$ 3.50 *4.00*
- Next 10,000 cubic feet per 100 cubic feet .15
- Over 11,000 cubic feet per 100 cubic feet .07 1/2

These prices pertain to 1/2 and 3/4 meters only.

The following minimum rates on meters will be charged:

1 " meter - - - - -	\$ 4.25	<i>4.75</i>
1 1/2 " meter - - - - -	4.50	<i>5.00</i>
1 1/2 " meter - - - - -	4.75	<i>5.25</i>
2 " meter - - - - -	5.00	<i>5.50</i>
3 " meter - - - - -	7.50	<i>8.00</i>
4 " meter - - - - -	12.00	<i>12.50</i>
5 " meter - - - - -	18.00	<i>18.50</i>
6 " meter - - - - -	30.00	<i>30.50</i>

Apartment Rates on 1/2 and 3/4 Meters:

- Duplex - - - - - \$ 4.00 Minimum
- Apartments - - - - - 4.00 plus 50% for each unit
- Cabin Courts - - - - - 4.00 plus 50% for each unit

For larger meters add difference between standard rates and on 1/2 and 3/4 to \$4.00 Minimum.

Section 3.

In addition to any other charges in this or any other Ordinance provided there shall be, effective September 1, 1951, a \$50.00 charge payable at the time of the meter connection on all new connections to the Kirkland Water System inside or outside of the city limits on all lines, either those owned by the city or over which the city has jurisdiction.

Section 4.

Any Ordinance or parts of ordinances herein repealed which are re-enacted in form or substance in this ordinance, shall not be construed as new enactments, but as continuances and amendments of such ordinances or parts of ordinances.

Section 5.

This ordinance shall be in force and take effect five days from and after its passage by the council, its approval by the Mayor and its publication according to law.
