

ORDINANCE NO. 613

AN ORDINANCE OF THE CITY OF KIRKLAND, DECLARING THAT THERE EXISTS A PUBLIC EMERGENCY OF THE CHARACTER ENUMERATED IN REMINGTON'S REVISED STATUTES, SECTION 9000-6, which said emergency could not reasonably have been foreseen at the time of making the budget for 1951, and appropriating the sum of ~~Six~~ Thousand Dollars (\$~~6~~,000.00) and authorizing the immediate expenditure of said sum for the purpose of seal coating and repairing streets where necessary in the area within L.I.D. 94, and other areas where necessary in excess of the estimated cost of the maintenance of the streets within the City of Kirkland.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

THAT WHEREAS, an emergency exists which affects the health and welfare of the population of the City of Kirkland, in that the streets within the City can not be properly maintained and protected without an immediate seal coating on the area within L.I.D. 94 and such other areas, and it is necessary that such work be done to adequately serve the needs of the citizens of Kirkland, and additional funds in the amount of ~~Six~~ Thousand Dollars (\$~~6~~,000.00) are necessary to pay the expenses thereof for the balance of the fiscal year of 1951.

AND WHEREAS, the Street Department would not reasonably have foreseen the necessity of said expenditure at the time of the preparation of the budget for the fiscal year of 1951, and the appropriation therefore by the City Council, now, therefore,

THE CITY COUNCIL OF THE CITY OF KIRKLAND DOES HEREBY FIND that an emergency exists for the appropriation of the sum of ~~Six~~ Thousand Dollars (\$~~6~~,000.00) to be used for said uses and purposes, and there is hereby appropriated for the Street Department of the City of Kirkland for the specified uses of seal coating and repairing the streets within the district of L.I.D. 94, and certain other necessary areas as allowed by said funds, the sum of ~~Six~~ Thousand Dollars (\$~~6~~,000.00). It is further ordained that the sum of ~~Six~~ Thousand Dollars (\$~~6~~,000.00) be transferred from the Replacement Fund of the Water Department as a loan from said Replacement Fund to be repaid to that Fund, together with

Interest thereon at the rate of NONE per cent per annum during the fiscal year of 1952.

This Ordinance is necessary for the immediate preservation of the Public health and welfare of the residents and citizens of the City of Kirkland, and is hereby declared to be in full force and effect immediately.

Introduced and emergency declared and this Ordinance passed and approved this 20<sup>th</sup> day of August, 1951.
