ORDINANCE NO. 618

AN ORDINANCE OF THE CITY OF KIRKLAND SETTING SALARY SCHEDULES FOR THE POLICE, STREET, WATER, SEWER, AND PARK DEPARTMENTS, RAISING SOME SALARIES AND PAY SCHEDULES AND AMENDING ANY ORDINANCES INCONSISTENT THEREWITH TO TAKE EFFECT AS OF JANUARY 1, 1952.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. That Section 1 of Ordinance No. 606 of the City of Kirkland which reads as follows:

"Section 1. The salaries of members of the Police Department of the City of Kirkland shall be as follows:

- (1) The first three months following appointment, \$250.00 per month.
- (2) From the fourth to twenty-fourth months, \$275.00 per month.
- (3) After two years the salary shall be \$290.00 per month.
- (4) The Chief of Police shall be paid \$300.00 per month."

be and the same hereby is repealed and amended to read as follows:

The salaries of members of the Police Department of the City of Kirkland shall be as follows:

- (1) The Chief of Police shall be paid \$325.00 per month.
- (2) There shall be two sergeants who shall be paid \$300.00 per month.
- (3) Patrolmen in the Police Department who shall work a six day week shall be paid the sum of \$290.00 per month.

Section 2. That Section 2 of Ordinance No. 606 which reads as follows:

"Section 2. The salaries of employees of the Park, Street, Sewer and Water Departments shall be.

- (1) \$250.00 per month for the first three months after employment
- (2) \$275.00 per month after the first three months.
- (3) The Superintendents of these Departments shall received \$300.00 per month."

be and the same hereby is repealed effective January 1, 1952.

Section 3. The salaries of employees of the Park Department shall be:

- (1) The Superintendent of the Park Department shall be paid \$325.00 per month.
- (2) All other employees shall receive \$275.00 per month.

Section 4. The salaries of the employees of the Street Department shall be:

(1) The Superintendent of the Street Department shall receive \$325.00 per month.

(2) The Assistant Superintendent of the Street Department shall receive \$300.00 per month.

(3) All other employees of the Street Department shall receive \$275.00 per month.

Section 5. The salaries of the employees of the Sewer Department shall be:

(1) The Superintendent of the Sewer Department shall receive \$325.00 per month.

(2) All other employees of the Sewer Department who shall work on a basis of a six day week shall receive \$290.00 per month.

Section 6. The salaries of the employees of the Water Department shall be:

(1) The Superintendent of the Water Department shall receive \$325.00 per month.

(2) The two lead men in the Water Department shall receive the sum of \$300.00 per month.

(3) The Reservoir Supervisor in the Water Department shall receive the sum of \$300.00 per month.

(4) All other employees of the Water Department shall receive the sum of \$275.00 per month.

Section 7. Section 3 of Ordinance No. 606 of the City of Kirkland which reads as follows:

" Section 3. The salaries provided for herein shall not apply to part time or special employees. The hourly wage in all Departments shall be \$1.35."

is hereby repealed and amended to read as follows:

The salaries provided for herein shall not apply to part time or special employees. The hourly wage in all Departments shall be \$1.50.

Section 8. That all Ordinances or parts of Ordinances inconsistent herewith be and the same hereby are repealed to the extent necessary to make this Ordinance effective.

Section 9. The salaries herein provided shall take effect as of January 1, 1952.

Section 10. This Ordinance shall be in force five days from and after its passage by the Council, approval by the Mayor, and publication according to law.
