ORDINANCE NO. 625

AN ORDINANCE OF THE CITY OF KIRKLAND, WASHINGTON, REGULATING THE PRESENCE OF MINORS AT PUBLIC BILLIARD HALLS, POOL ROOMS, TENTS AND OTHER PLACES WHERE THE GAMES OF POOL AND BILLIARDS OR EITHER OF THEM ARE PLAYED AND CARDS ARE PLAYED AND/OR ALCOHOLIC BEVERAGES OR LIQUOR ARE SOLD; REPEALING ORDINANCE NO. 85 OF THE CITY OF KIRKLAND; AND PROVIDING A PENALTY FOR THE VIOLATION OF THIS ORDINANCE.

THE CITY COUNCIL OF THE CITY OF KIRKLAND DO ORDAIN AS FOLLOWS:

Section 1. It shall be unlawful for any proprietor, manager, or agent of such proprietor or manager of any place or places where the game or games of pool or billiards, is or are conducted or played publicly for hire or advertised to be so conducted, to allow any game or games of billiards or pool to be so conducted or played at any room, or rooms, hall or halls, booth or booths, tent or tents, in which minor or minors under the age of 21 years shall be present, where in any such room, place or establishment cards are played and/or alcoholic beverages or liquor is sold. And it shall be unlawful for any such proprietor, manager or agent to allow minor or minors under the age of 21 years to enter such room, hall, tent or booth, where such game or games of pool or billiards are conducted and where also cards are played and/or alcoholic beverages or liquor is sold, whether such games be in process or not.

Section 2. It shall be unlawful for any proprietor, manager, or agent of such proprietor or manager of any place or places where the game or games of pool or billiards is or are conducted or played publicly for hire or advertised to be so conducted, to allow any game or games of billiards or pool to be so conducted or played at any room, or rooms, hall or halls, booth or booths, tent or tents, in which minors under the age of 21 years shall be present unless all of said pool or billiard tables are visible from the public street, sidewalk or way. And it shall be unlawful for any such proprietor, manager, or agent

to allow minors under the age of 21 years to enter such room, hall, tent or booth where pool or billiards are conducted on table or tables not plainly visible from the street, sidewalk or public way, whether such games be in process or not.

Section 3. Ordinance No. 85 of the City of Kirkland is hereby repealed.

Section 4. Any person or persons violating any provision of this Ordinance shall be deemed guilty of a misdemeanor and upon conviction thereof shall be fined not to exceed \$25.00 or imprisonment in jail for a term not to exceed 10 days.
